**Resolution:** *Consideration of the item was deferred.*

- 05(e) To place before the Executive Council of Vidyasagar University, the report bearing letter No. VU/CL/ADM/Report/76/22 dated 07.07.2022 submitted by the In-charge of the Central Library of Vidyasagar University regarding not returning the borrowed books by Shri Debesh Chandra Bhattacharya, former Assistant Professor, Department of Microbiology of Vidyasagar University.

**Resolution:** *The Executive Council (EC) of Vidyasagar University noted the report bearing letter No. VU/CL/ADM/Report/76/22 dated 07.07.2022 prepared and submitted by the In-charge of the Central Library of Vidyasagar University stating that Shri Debesh Chandra Bhattacharya, former Assistant Professor (Contractual), Department of Microbiology of Vidyasagar University bearing Card No. CFMBMY140001 has borrowed Fifteen (15) numbers of books from the Central Library between 26/02/2014 and 31/08/2017 but till date he has not renewed/returned the said books. The Executive Council noted also that the concerned Department issued a circular requesting all stakeholders of the University to renew or return their borrowed books by 30.06.2022 and based on the said circular, Shri Bhattacharya in a letter dated 21.06.2022 informed his inability to renew/return the same by 30.06.2022. The Executive Council noted further that thereafter, one and half months have already elapsed but Shri Bhattacharya*

*either not renew/returns the said books nor communicates anything in this regard till date. As per the library rules Shri Bhattacharya shall have to return the said books or he may pay the cost of the latest edition of such borrowed books, i.e. Rs.74,780/- (Rupees Seventy four thousand seven hundred eighty) only for this purpose.*

*After thorough discussion on the report submitted by the In-charge of the Central Library of Vidyasagar University regarding not returning the borrowed books by Shri Debesh Chandra Bhattacharya, former Assistant Professor, Department of Microbiology of Vidyasagar University, it was resolved that Shri Bhattacharya be asked to return the fifteen (15) numbers of books as borrowed by him from the Central Library immediately. Resolved also that Shri Bhattacharya be also requested to intimate us the date of his visit at the University for this purpose well in advance. Resolved further that the Registrar be requested to communicate the same to the concerned incumbent in this regard.*

- 05(f) To consider the letter dated 12.07.2022 submitted by Shri Arindam Bhattacharya, Development Officer of Vidyasagar University praying for permitting him to stay at A-11 of Sushil Dhara Abasan at the residential campus of Vidyasagar University for at least two (02) years.

**Resolution:** *The Executive Council (EC) of Vidyasagar University noted the letter dated 12.07.2022 submitted by Shri Arindam Bhattacharya, Development Officer of Vidyasagar University stating that at present he is residing at A-11 of Sushil Dhara Abasan in the residential campus of Vidyasagar University alongwith his family members. Very recently the University issued a Notification related to the Rules and Regulations for allotment of the University Quarter/Hostel and accordingly he is not permissible to stay at the University Quarter/Hostel as he has a flat at Sangam Garden Society at Tantigeria, Midnapore near to Vidyasagar University. The Executive Council noted also that he has a six years old son who is suffering from mental problems (diagnosed as autistic child) since 2018 and taking various therapy, like Speech Therapy, Occupational Therapy, Special Education etc. at Peerless Hospital and NIMHANS, Bangalore, Karnataka. If they change their quarter, the environment will also be changed and for this reason many behavioral issues of his son will arise as his son is accustomed to the present environment. In this connection, he has requested to permit him to stay at the A-11 of Sushil Dhara Abasan for at least two years on humanitarian grounds.*

*After careful consideration of the letter submitted by Shri Arindam Bhattacharya, Development Officer of Vidyasagar University praying for permitting him to stay at A-11 of Sushil Dhara Abasan at the residential campus of Vidyasagar University for at least two (02) years, it was resolved that considering on the humanitarian grounds, Shri Bhattacharya alongwith his family members be permitted to stay at the above Unit of Sushil Dhara Abasan for a period of one (01) year as a special case with effect from the date of taking such decision. Resolved also that the Registrar of this University be requested to do the needful in this regard.*

- 05(g) To consider the proposal bearing letter dated 11.07.2022 jointly submitted by the President and the Joint Secretaries of Vidyasagar University Officers' Association (VUOA) regarding extending the LTC facility for the officers community of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the proposal bearing letter dated 11.07.2022 jointly submitted by the President and the Joint Secretaries of Vidyasagar University Officers' Association (VUOA) stating that the University Officers' who are one of the important pillars in academic administration are not getting any LTC facility till date and are deprived from*



such facility. The Executive Council noted also that the Faculty members and the staff member are having LTC facility and they are enjoying the same as per the rule of the University. In this connection they are requested to consider their appeal and extend such LTC facility to the officers including the officers engaged in this University on contractual manner. The Executive Council noted further that they have proposed that each officer should be to avail LTC once in their service life with their family members to visit within India after ten years of regular service and to visit abroad after twenty years of regular service in the neighbouring countries and maximum amount of re-imbursement may be basic of one month on the month of availing of the facility.

After thorough discussion on the proposal jointly submitted by the President and the Joint Secretaries of Vidyasagar University Officers' Association (VUOA) regarding extending the LTC facility for the officers community of Vidyasagar University, it was resolved that the said proposal of the Vidyasagar University Officers' Association be accepted in principle and the proposal be forwarded to the Department of Higher Education, Government of West Bengal for necessary advice/approval in this regard. Resolved further that the Registrar of this University be requested to do the needful in this regard.

- 05(h) To consider the letter bearing No. VU/COS/79/22 dated 20.07.2022 submitted by the Head, Department of Computer Science of Vidyasagar University regarding filling up of three (03) vacant full-time contractual teaching posts in the Department of Computer Science of Vidyasagar University.

**Resolution:** The Executive Council (EC) of Vidyasagar University noted the letter bearing No. VU/COS/79/22 dated 20.07.2022 submitted by the Head, Department of Computer Science of Vidyasagar University stating that three (03) numbers of the contractual full-time teaching posts in the Department of Computer Science have been lying vacant since the recent past. The Departmental Committee of the said Department in its meetings dated 29.04.2022 & 14.07.2022 respectively decided to fill-up these vacant posts in the larger interest of the students of the Department as soon as possible. In this connection he has requested to consider the matter for smooth running two programmes of M.Sc. in Computer Science & MCA of the said Department and also to distribute the academic load amongst the faculties.

After thorough discussion on the proposal regarding filling up of three (03) vacant full-time contractual teaching posts in the Department of Computer Science of Vidyasagar University, it was resolved that two (02) vacant full-time contractual teaching posts in the Department of Computer Science be filled up as per the norms of the University as a special case for the larger interest of the students of the Department. Resolved also that the panel of the Selection Committee for this purpose be constituted for the recruitment of the said teaching posts and regarding nomination of experts in the Selection Committee the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved further that the Registrar and Dr. Jitendranath Murmu, Junior Supdt. of the Establishment Section of this University be requested to process further regarding this immediately.

- 05(i) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 19.07.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding reducing the basic pay of Shri Sujit Adhikary, Senior Assistant, Office of the Finance of Vidyasagar University after promotion.

**Resolution:** The Executive Council of Vidyasagar University noted the Note sheet dated 19.07.2022 prepared and submitted by Dr. Jitendranath Murmu, Junior Supdt. of the Establishment Section of Vidyasagar University based on the prayer submitted by Shri Sujit Adhikary, Senior Assistant, Department of Finance of Vidyasagar University

regarding reducing his basic pay after promotion, stating that Shri Adhikary joined Vidyasagar University as Junior Assistant since 24.01.2011. On completion of ten years of continuous service in the post of Junior Assistant, he was placed in the higher pay band under the Career Advancement Scheme (CAS) with effect from 12.03.2021 and his Basic pay was fixed Rs.42,000/-. Subsequently on fulfillment of the ratio on completion of 9 years of continuous service he has been promoted to the post of Senior Assistant with effect from 24.01.2020 and as per the pay matrix his Basic pay has been fixed Rs.41,500/- which is less than the basic pay drawn by Shri Adhikary after getting the CAS. The Executive Council noted further that in terms of the G.O. bearing No. 1083(8)-Edn dated 10.08.1990 of the Higher Education Department, it is stated that "A non-teaching employee whose scale of pay of the promotion post in next higher scale gets promotion after enjoying the benefit of CAS for twenty years, he will be allowed to retain the higher scale in the promotion post, as personal to him and his pay on promotion will be fixed in terms of the relevant rules of the University.

After thorough discussion on the note sheet prepared and submitted by Dr. Jitendranath Murmu, Junior Supdt. of the Establishment Section of Vidyasagar University regarding reducing the basic pay of Shri Sujit Adhikary, Senior Assistant, Office of the Finance of Vidyasagar University after promotion alongwith the supporting documents and after careful consideration of the prayer submitted by Shri Adhikary in this regard, it was resolved that a Committee be constituted to look into the matter and to give their fruitful suggestions in this regard considering the prayer of the incumbent concerned, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved also that regarding nomination of persons/experts in the Committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved further that the said Committee be also requested to look after promotion/placement/pay fixation/fixation of increment and all other related matters of the employees of the University which will be considered by the EC in this meeting and the Registrar of the University be requested to do the needful in this regard.

- 05(j) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 28.07.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding placement of three Non-teaching Staff, namely, Sk. Ali Hossain, Accountant, Shri Debasish Patra, Cashier and Shri Manas Kumar Barik, Senior Stenographer of Vidyasagar University to the Pay Band of Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/- under the Career Advancement Scheme (CAS).

**Resolution:** The Executive Council of Vidyasagar University noted that as approved by the Ninth Executive Council of Vidyasagar University in its Thirteenth (13th) meeting held on 09.06.2022 based on the recommendations of the Establishment Committee of Vidyasagar University taken in its meeting held on 27.05.2022, three Non-teaching Staff, namely, Sk. Ali Hossain, Accountant, Shri Debasish Patra, Cashier and Shri Manas Kumar Barik, Senior Stenographer of Vidyasagar University were placed to the higher Pay Band of Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/- under the Career Advancement Scheme (CAS) in terms of the G.O. bearing No. 1083(8)-Edn(U) dated 18.08.1990 of the Higher Education Department, Government of West Bengal and the same was communicated to the office of the Finance of this University for implementation. The Executive Council noted also that the Finance Officer of this University has fixed their placement benefits in the Pay Band of Rs.15,600-39,100 with Grade Pay of Rs.5,400/- instead of Grade Pay of Rs.6,000/- without any information/prior approval from the competent authority or the incumbents

concerned although in the Pay Slips of the incumbents concerned for the month of June, 2022 where the Pay Band stated as Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/- as per the communications received from the incumbents concerned in this regard. The Executive Council noted further that on 25.07.2022 the Finance Officer of Vidyasagar University prepared and submitted a Note Sheet bearing No. VU/FO/397/2022 dated 25.07.2022 regarding pay fixation for recent CAS of three non-teaching employees to the unrevised pay scale of Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/- stating that as there is no provision of 6,000 G.P. in the G.O. No. 700(12)-Edn(U) dated 10.12.2019 - ROPA 2009 for the Non-teaching employees, they have fitted the concerned non-teaching employees in Level-1 of Schedule-II (Part-B) of G.O. No. 198(22)-Edn(U) dated 19.02.2020 in the Pay Band of Rs.15,600-39,100/- with Grade Pay of Rs.5,400/-. The Finance Officer has also requested either the direction be given in clear terms which G.O. they have to follow in pay fixation of those non-teaching staff in the revised pay structure with effect from 01.01.2020 actual or advice may be sought from the Higher Education Department, Government of West Bengal. The Executive Council noted again that based on the above, the Establishment Section has prepared and submitted a note sheet dated 28.07.2022 stating that the pay of the above incumbents, namely, Sk. Ali Hossain, Shri Debasis Patra and Shri Manas Kumar Barik may be fixed on the Pay Band of Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/-.

After thorough discussion on the note sheet prepared and submitted by Dr. Jitendranath Murmu, Junior Supdt. of the Establishment Section of Vidyasagar University regarding placement of three Non-teaching Staff, namely, Sk. Ali Hossain, Accountant, Shri Debasish Patra, Cashier and Shri Manas Kumar Barik, Senior Stenographer of Vidyasagar University to the Pay Band of Rs.15,600 - 39,100/- with Grade Pay of Rs.6,000/- under the Career Advancement Scheme (CAS) & after careful consideration of the prayers submitted by the incumbents concerned in this regard and subsequently the Note sheet put forward by the Finance Officer of Vidyasagar University, in this regard, it was resolved that a Committee as constituted vide Item No. 05(i) to look into the matter and to give their fruitful suggestions in this regard considering the prayers of the incumbents concerned, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved further that the Registrar of the University be requested to do the needful in this regard.

- 05(k) To consider the letter dated 12.07.2022 submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University regarding rectification of the anomalies of his actual pay that reflected in the Pay Slip with effect from the date of his placement.

**Resolution:** The Executive Council of Vidyasagar University noted the letter submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor stating that he was shocked and surprised to find an anomaly in his salary which came to his notice very recently. The pay slip issued to him by the Finance Department of Vidyasagar University for the month of June, 2022 reveals that his pay has not been actually fixed in the Grade Pay of Rs.6,000/- instead it has been fixed in the Grade pay of Rs.5,400/- though in the Pay slip it has been stated the Grade Pay of Rs.6,000/-. The Executive Council noted also that this incident is continuing since he was actually placed in the Grade Pay of Rs.6,000/- as stated by Shri Paul and it has been done by the Finance Officer without any information/prior approval of the competent authority or the incumbent concerned. In this connection he has



*requested to rectify the anomaly of his actual pay which has been reflected in the Pay Slip issued by the Finance Officer.*

*After thorough discussion on the letter submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University regarding rectification of the anomalies of his actual pay that reflected in the Pay Slip with effect from the date of his placement, it was resolved that a Committee as constituted vide Item No. 05(i) to look into the matter and to give their fruitful suggestions in this regard considering the prayer of the incumbent concerned, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved further that the Registrar of the University be requested to do the needful in this regard.*

- 05(l) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 18.07.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding placement of Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I, office of the Finance of Vidyasagar University in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- in terms of G.O. No. 1083(8)-Edn(U) dated 10.08.1990.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note sheet dated 18.07.2022 prepared and submitted by the Establishment Section of Vidyasagar University based on the prayer dated 17.06.2022 submitted by Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I of Vidyasagar University for placement in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- in comparison with the service records of Shri Manas Kumar Barik, Senior Stenographer of Vidyasagar University alongwith disclosing his all confidential information and supporting documents which are the custodian of the University, in terms of the G.O. bearing No. 1083(8)-Edn(U) dated 10.08.1990. The Executive Council noted also that the Establishment Section in his note sheet has stated that in terms of the Government Order No. 1083(8)-Edn(U) dated 10.08.1990 " a non-teaching employees who has completed service of ten years or longer without any promotion will move from the revised scale in relation to him to the first higher scale and after serving in that scale for 20 years will get advancement to the second higher scale, provided that the total period of his service in that first two scales is not less than 20 years". The Executive Council noted further that a non-teaching employee who has got a normal promotion on completion of 09 years in his service life may not be eligible to move to pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- on completion of twenty years from the date of his joining as stated further by the Establishment Section in his aforesaid note sheet.*

*After thorough discussion on the Note Sheet dated 18.07.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding placement of Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I, office of the Finance of Vidyasagar University in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- in terms of G.O. Such a gold medal will be awarded to a student who stood first in M.A. Final Examination in Political Science (Regular Course) of Vidyasagar University. In this connection he has requested to introduce the same at the University and let him know the modalities for this purpose and also the amount to be deposited for this purpose.*

*After thorough discussion on the proposal submitted by Professor Ambarish Mukhopadhyay, Department of Political Science of Vidyasagar University, now retired from his service, praying for creation of an Endowment Gold Medal in the name of Late Justice Nirmal Chandra Mukherji and Late Smt. Reba Mukherji Memorial Gold Medal at Vidyasagar University, it was resolved that the said proposal of Professor Mukhopadhyay be accepted and the Finance Officer of this University be requested to communicate the modalities and also the amount to be deposited for this purpose to Professor Mukhopadhyay in this regard.*

- 05(n) To place before the Executive Council of Vidyasagar University, the proposal bearing Note Sheet dated 30.06.2022 prepared and submitted by the OSD, Registrar's Office of this University regarding the information related to the mode of studies and the medium of instructions of the undergraduate/postgraduate degrees of Vidyasagar University.

In this connection she has requested to permit for issuing a notification regarding the information related to the mode of studies and the medium of instructions to be provided to the candidates by the Principal(s)/Teachers-in-Charge of the college concerned in case of colleges affiliated to Vidyasagar University and the Head of the Departments concerned in case of the University.*

*After thorough discussion on the proposal submitted by the OSD, Registrar's Office of this University regarding the information related to the mode of studies and the medium of instructions of the undergraduate/postgraduate degrees of Vidyasagar University, it was resolved that the said proposal of the OSD be accepted and a notification stating that the Principal(s)/Teacher(s)-in-Charge of the colleges concerned will provide the information regarding the mode of studies and the medium of instructions in case of the students pursued their UG & PG courses from the Colleges affiliated to Vidyasagar University and the Head of the Departments concerned will provide such information in case of the students pursued their PG courses from the University henceforth be issued for information of all concerned as desired by the OSD. Resolved further that the Registrar be requested to process further regarding this.*

**Resolution:** *The Executive Council noted that in terms of the decision taken by the Ninth Executive Council of Vidyasagar University in its Thirteenth (13th) meeting held on 09.06.2022 wherein Dr. Siddhartha Sankar Dash, former Senior Medical Officer of Vidyasagar University was granted study leave with full pay and allowances during the period from 07.08.2014 to 06.08.2016 taken by him for his higher study of Doctor of Medicine at KIIT excluding seven months study leave availed by him earlier for this purpose and his pay for seventeenth (17) months study leave be fixed after deducting the stipend, if any, received by him during pursuing his M.D. course from KIIT. The Executive Council noted further the Note Sheet dated 10.08.2022 prepared and submitted by Dr. Jiten Murmu, Junior Supdt. of the Establishment Section, duly recommended by the Registrar of Vidyasagar University regarding the stipend amount received by Dr. Siddhartha Sankar Dash, former Senior Medical Officer of Vidyasagar University during the period of pursuing Doctor of Medicine (MD) course at KIIT.*

*After thorough discussion on the submitted by the Establishment Section of Vidyasagar University regarding the stipend amount received by Dr. Siddhartha Sankar Dash, former Senior Medical Officer of Vidyasagar University during the period of pursuing Doctor of Medicine (MD) course at KIIT and careful consideration of the decision taken by the Executive Council in its earlier meeting, it was resolved that Dr. Dash be granted total twenty four (24) months study leave with full pay and allowances taken by him for the purpose of his higher study of Doctor of Medicine at Apollo Hospital, Chennai (from 28.04.2003 to 23.11.2003) together with KIIT, Bhubaneswar (from 07.08.2014 to 06.11.20216) and his pay for twenty four (24) months study leave be released after deducting the stipend received by Dr. Dash during pursuing his M.D. course from Apollo Hospital, Chennai and KIIT, Bhubaneswar respectively reconsidering the decision of the Executive Council of this University taken in its earlier meeting held on 09.06.2022 regarding releasing of study leave with full pay and allowances of seventeen (17) months. Resolved further that the Registrar and the Finance Officer of this University be requested to process further in this regard.*

The Executive Council also noted the detailed guidelines specified by the Higher Education Department for this purpose.

After thorough discussion on the notification issued by the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding requirement of the guidance and approval from the West Bengal State Council of Higher Education for introduction of any courses in any Government-aided/Government Colleges and Self-Financing Colleges, it was resolved that the said advisory of the Higher Education Department, Government of West Bengal be followed in case of introduction of any courses in any Government-aided/Government Colleges and Self-Financing Colleges henceforth. Resolved further that the Inspector of Colleges of this University be requested to circulate the same amongst the colleges imparting the UG & PG Courses under the affiliation of Vidyasagar University in discussion with the Secretary, Faculty Councils for Postgraduate Studies and the Secretary, Council for Undergraduate Studies of this University.

- 05(r) To place before the Executive Council of Vidyasagar University, the letter dated 01.07.2022 received from Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University in reply to the letter bearing No. VU/R/9EC-11/C0155/2022 dated 19.04.2022 issued by the University to him requesting for informing/intimation the password of the e-mail address vcvu.confidential@gmail.com. created by the University for the Vice-Chancellor.

In this connection the Chairman & Director has requested to increase 100 intake in addition to the existing intake of 500 from the academic session 2022-2023.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 30.08.2022 submitted by Shri Nayan Ranjan Mahapatra, former Senior Superintendent of Vidyasagar University in continuation to his earlier prayers dated 12.04.2022 & 27.06.2022 stating that his pay in the post of Senior Superintendent was fixed at Rs.20,920/- but his actual pay should be Rs.21,550/- since his joining the post, i.e. from 22.11.2017 as his pay in the previous post of Senior Assistant alongwith the CAS was higher than the minimum of entry level of pay. In this connection he has requested to consider his prayer and to grant him one increment on fixation in the post of Senior Superintendent at Vidyasagar University as per the G.O. No. 10570-F(P) dated 25.11.2009 in Part-C of Annexure-1 of the Higher Education Department, Government of West Bengal.

After thorough discussion on the letter submitted by Shri Nayan Ranjan Mahapatra, former Senior Superintendent of Vidyasagar University praying for sanction of one increment on fixation in the post of Senior Superintendent of this University as per the G.O. No. 10570-F(P) dated 25.11.2009 in Part-C of Annexure-1 of the Higher Education Department, Government of West Bengal, it was resolved that the said Committee as constituted vide item No. 05(i) be requested

to look into the matter and to give their fruitful suggestions in this regard considering the prayer of the incumbent concerned, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved further that the Registrar of the University be requested to do the needful in this regard.

- 05(z-8) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 07.09.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding placement/promotion of Shri Kingshuk Aich, Shri Ratnakar Kundu, Shri Surajit Sen, Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I, Shri Ananta Kumar Duary, Shri Anindita Mitra and Shri Biswanath Tudu in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- in terms of G.O. No. 1083(8)-Edn(U) dated 10.08.1990.

**Resolution:** The Executive Council of Vidyasagar University noted the Note Sheet dated 07.09.2022 prepared and submitted by Dr. Jitendranath Murmu, Junior Superintendent of the Establishment Section of Vidyasagar University based on the mass petition dated 24.08.2022 submitted by Shri Kingshuk Aich, Shri Ratnakar Kundu, Shri Surajit Sen, Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I, Shri Ananta Kumar Duary, Shri Anindita Mitra and Shri Biswanath Tudu for removal of the anomaly of movement on CAS/Promotion from Rs.4,600 Grade Pay to Rs.6,000 Grade Pay for placement in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/-. The Executive Council noted also that the Establishment Section in his note sheet has stated that in terms of the Government Order No. 1083(8)-Edn(U) dated 10.08.1990 " a non-teaching employees who has completed service of ten years or longer without any promotion will move from the revised scale in relation to him to the first higher scale and after serving in that scale for 20 years will get advancement to the second higher scale, provided that the total period of his service in that first two scales is not less than 20 years. The Executive Council noted further that a non-teaching employee who has got a normal promotion on completion of 09 years in his service life may not be eligible to move to pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- on completion of twenty years from the date of his joining" stated by the Establishment Section in the aforesaid note. The Executive Council noted again that considering the above out of the above incumbents Shri Biswanath Tudu, Technical Assistant, Grade-II enjoying the Pay Band of Rs.4,600 is eligible to move to the next higher scale of pay i.e. Pay Band of Rs.15,000 - 39,100 with Grade Pay of Rs.6,000/- on completion of 20 (twenty) years from the date of his joining. After thorough discussion on the Note Sheet dated 07.09.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding placement/promotion of Shri Kingshuk Aich, Shri Ratnakar Kundu, Shri Surajit Sen, Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I, Shri Ananta Kumar Duary, Shri Anindita Mitra and Shri Biswanath Tudu in the unrevised pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- in terms of G.O. No. 1083(8)-Edn(U) dated 10.08.1990, it was resolved that the said Committee as constituted vide item No. 05(i) be requested to look into the matter and to give their fruitful suggestions in this regard considering the prayer of the incumbents concerned, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved further that the Registrar of the University be requested to do the needful in this regard.



05(z-9) To place before the Executive Council of Vidyasagar University, the Articles of Charge framed against Shri Prabir Das, Driver of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted that in terms of the decision taken by the Ninth Executive Council of Vidyasagar University in its Fourteenth (14th) meeting held on 29.06.2022 based on different communications made with Shri Prabir Das, Driver of Vidyasagar University and subsequent his reply letters received by the University in this regard pertaining to making some insulting and derogatory remarks about the University in the University premises and its Vice-Chancellor, engaging himself for another parallel private activity/job without any information of the University authority and also lodging the false, baseless, concocted with malicious intention and ulterior motive to malign the image of the University and its administration without the information and prior approval of the University authority, the above articles of charges framed against Shri Das for dereliction of duty, insubordination and unbecoming of an employee. The Executive Council noted the detailed Articles of Charge framed against Shri Prabir Das, Driver of Vidyasagar University for this purpose.*

*After thorough discussion on the the Articles of Charge framed against Shri Prabir Das, Driver of Vidyasagar University pertaining to making some insulting and derogatory remarks about the University in the University premises and its Vice-Chancellor, engaging himself for another parallel private activity/job without any information of the University authority and also lodging the false, baseless, concocted with malicious intention and ulterior motive to malign the image of the University and its administration etc. without the information and prior approval of the University authority, it was resolved that the said Articles of Charge be accepted the Registrar and Dr. Jiten Murmu, Junior Supdt. of the Establishment Section of this University be requested to process further to issue the said Articles of Charge in favour of the incumbent concerned immediately.*

05(z-10) To place before the Executive Council of Vidyasagar University, the Medical Leave Statement in respect of Shri Ram Kumar Bhakat, Associate Professor, Department of Botany of Vidyasagar University prepared and submitted by the Establishment Section of this University.

**Resolution:** *The Executive Council of Vidyasagar University noted the Medical Leave Statement in respect of Shri Ram Kumar Bhakat, Associate Professor, Department of Botany of Vidyasagar University prepared and submitted by Dr. Jiten Murmu, Junior Supdt. of the Establishment Section, duly recommended by the Registrar of this University. The Executive Council noted also that Shri Bhakat has taken the leave for his sickness lastly with effect from 29.03.2022 to 29.09.2022 for 185 days. His accumulated medical leave balance on 07.09.2022 is 145 days and he is entitled to get 180 days full pay medical leave during his entire service life. He has already taken 125 days full pay medical leave out of 180 days in the past. He is only entitled to get 55 days full pay medical leave out of 145 days medical leave and the rest of 130 days may be granted to him from Earned Leave (178 days) on medical grounds.*

*After thorough discussion on the Medical Leave Statement in respect of Shri Ram Kumar Bhakat, Associate Professor, Department of Botany of Vidyasagar University prepared and submitted by the Establishment Section of this University, it was resolved that only 55 days full pay medical leave out of 185 days and the rest of 130 days be granted to him from Earned Leave on medical ground as proposed by Dr. Jiten Murmu, Junior Supdt. of the Establishment Section and further leave, if any, required by Shri Bhakat for this purpose be granted to him from the Earned Leave on medical ground. Resolved further that the Registrar and Dr. Jitendranath Murmu, Junior Superintendent of the Establishment Section of this University be requested to process further regarding this.*

05(z-11) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 08.09.2022 prepared and submitted by the Establishment Section of Vidyasagar University regarding the anomaly for pay fixation of Shri Goutam Pal, Finance Officer of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 08.09.2022 prepared and submitted by Dr. Jitendranath Murmu, Junior Superintendent of the Establishment Section stating that after examining the pay fixation orders of various employees prepared and sent by the office of the Finance of this University where an anomaly regarding pay fixation of Shri Gautam Pal, the Finance Officer of Vidyasagar University has been observed. The Executive Council noted also that Shri Gautam Pal joined this University on 04.09.2018 (notionally on 01.09.2018). Before his joining at Vidyasagar University Shri Pal served as Comptroller at Bidhan Chandra Krishi Viswavidyalaya from 09.04.2015 to 31.08.2018. According to the Last Pay Certificate submitted by Shri Pal his last basic pay was Rs.55,620/- (pre-revised). The Executive Council noted further that the Basic Pay of Shri Pal at this University in the pre-revised scale should be Rs.55,620/- + one usual increment as per the norms of the University, i.e. Rs.57,290/- as on 01.09.2018. On 01.07.2019 his basic pay in the pre-revised scale should be fixed at Rs.59,010. In terms of the revised pay scale his revised basic for July, 2018 should be at Rs.1,48,500/- but the revised Basic Pay of Shri Pal has been fixed at Rs.1,48,500/- for July 2016. So there is some anomaly in fixation of pay of Shri Pal in the fixation order prepared and submitted by the office of the Finance*

*After thorough discussion on the Note Sheet prepared and submitted by Dr. Jitendranath Murmu, Junior Superintendent of the Establishment Section of Vidyasagar University regarding the anomaly for pay fixation of Shri Goutam Pal, Finance Officer of Vidyasagar University, it was resolved that the said Committee as constituted vide item No. 05(i) be requested to look into the matter and to give their fruitful suggestions in this regard considering the note prepared and submitted by the Establishment Section, relevant G.O. of the Higher Education Department, Government of West Bengal including other supporting documents and also as per the norms of the University for further consideration of the Executive Council. Resolved further that the Registrar of the University be requested to do the needful in this regard.*

05(z-12) To place before the Executive Council of Vidyasagar University, the matter regarding conferment of "Vidyasagar Puraskar" of Vidyasagar University for the year 2022.

**Resolution:** *The Executive Council of Vidyasagar University noted that like previous years, this year, 2022, the University has already taken initiative to award the "Vidyasagar Puraskar" to the nominated recipients on the occasion of 203rd Birth Day Anniversary of Pandit Iswar Chandra Vidyasagar. The Executive Council noted further that a Search Committee was constituted by the Hon'ble Vice-Chancellor for this purpose and based on the recommendation of the Search Committee, Shri Amarnath Mitra, Outstanding Personality in the field of Renowned Writer, Dr. G.N. Devy, Outstanding personality in the field of Renowned Language & Culture, Shri Goutam Mukhopadhyay, Outstanding personality in the field of Theatre and Roshenara Khan, Outstanding personality in the field of Renowned Writer and Social Activist have been nominated for the said Vidyasagar Puraskar and the Awarding Ceremony for this purpose will be held on 22.09.2022 at the University campus.*

After thorough discussion on the matter regarding conferment of "Vidyasagar Puraskar" of Vidyasagar University for the year 2022, it was resolved that the recipients who have been nominated for the award of "Vidyasagar Puraskar – 2022", namely Shri Amarnath Mitra, Dr. G.N. Devy, Shri Goutam Mukhopadhyay and Rosenara Khan based on the Search Committee constituted for this purpose be accepted and forwarded to the Court for approval. Resolved further that the action taken by the University for communicating the concerned Awardees for this purpose be also ratified.

- 05(z-13) To place before the Executive Council of Vidyasagar University, the matter regarding conferment of Endowment Award, namely, "Professor Sudhir Ranjan Das Smriti Puraskar" of Vidyasagar University for the year 2022.

**Resolution:** The Executive Council of Vidyasagar University noted that this year, 2022, Vidyasagar University is going to confer an Endowment Award, namely, "Professor Sudhir Ranjan Das Smriti Puraskar" to the renowned personalities of an Ancient Indian History as well as eminent Archaeologist or any renowned Historian in the Arena of Ancient History or Archaeology on the occasion of 203rd Birth Day Celebration of Pandit Iswar Chandra Vidyasagar, donated by Ms. Annapurna Chattopadhyay, Fellow of the Asiatic Society and the University has already taken initiative to award the said Puraskar. The Executive Council noted also that a Search Committee was constituted by the Hon'ble Vice-Chancellor for this purpose and based on the recommendation of the Search Committee, Dr. Supriya Verma, Associate Professor, Jawaharlal Nehru University has been nominated as a renowned Archaeologist/Anthropologist for the said Professor Sudhir Ranjan Smriti Puraskar firstly. As he is unable to take the said Puraskar from the University physically, Dr. Subha Majumder, Superintending Archaeologist, Archaeological Survey of India has been selected further as an eminent Archaeologist for this purpose and the Awarding Ceremony for this purpose will be held on 22.09.2022 at the University campus.

After thorough discussion on the matter regarding conferment of Endowment Award, namely, "Professor Sudhir Ranjan Das Smriti Puraskar" of Vidyasagar University for the year 2022, it was resolved that the recipient who have been nominated for the award of "Sudhir Ranjan Das Smriti Puraskar", namely Dr. Subha Majumder based on the Search Committee constituted for this purpose be accepted and forwarded to the Court for approval. Resolved further that the action taken by the University for communicating the concerned incumbent for this purpose be also ratified.
