In this connection, he has sought for necessary permission from the University to apply regarding his promotion/re-designation to the post of Professor from Associate Professor. After thorough discussion on the letter submitted by Dr. Joydev Maity, Associate Professor (on contractual), Department of Fishery Sciences of Vidyasagar University seeking permission to apply regarding his promotion/re-designation to the post of Professor from Associate Professor, it was resolved that the Registrar be requested to enquire whether such provision is implemented by any State-aided Universities specially by Jadavpur University and after getting such a reply from Jadavpur University, the matter be placed before the Executive Council for further consideration.

06(k) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/FO/40/2022 dated 27.04.2022 received from the Finance Officer of Vidyasagar University regarding his opinion pertaining to payment of bill against the repeat order for PG Part-I SLMs printing of DDE without the approval of the then Vice-Chancellor.

Resolution: Consideration of the item was deferred.

06(l) To consider the letter dated 22.04.2022 submitted by Shri Prabir Das, Driver of Vidyasagar University praying for permission to stay in his Unit at Bankim Chandra Abasan of Vidyasagar University allotted by the University to him.

Resolution: The Executive Council of Vidyasagar University noted that Shri Prabir Das was issued a letter by the University bearing No. VU/R/482/2022 dated 19.04.2022 for vacating the Unit at the Bankim Chandra Abasan provided by the University to him within one month from the date of issue of the letter as it has been reported/observed that he has the owner of a house, in full or part, either in his name or in the name of any other dependent member of his family within twenty five KMs of radius. The Executive Council noted further that in reply to that Shri Das has submitted a letter dated 22.04.2022 praying for permission to stay in his allotted Unit at the Bankim Chandra Abasan as he has no house of his own and there is a little house in the name of his mother and due to the family disturbances it is not possible to him to stay at his mother's house.

After thorough discussion on the letter submitted by Shri Prabir Das, Driver of Vidyasagar University praying for permission to stay in his Unit at Bankim Chandra Abasan of Vidyasagar University allotted by the University to him, it was resolved that the prayer of Shri Das regarding permitting him to stay in the Unit at Bankim Chandra Abasan be declined. Resolved further that Shri Das be requested to vacate the said Unit No. 04 of Bankim Chandra Abasan within fifteen(15) days from the date of receipt of this letter positively. Resolved again that the Registrar and the Establishment Section of the University be requested to process further in this regard.

06(m) To place before the Executive Council of Vidyasagar University, the Order bearing Memo No. 1180-F(Y) dated 23.03.2022 issued by the Joint Secretary to the Government of West Bengal, Finance Department, Audit Branch regarding extension of 'e-Services for Employees' facility to teaching and non-teaching employees of Universities, Grant-in-Aid Colleges and employees of other Grant-in-aid Institutions, drawing their Pay Bill through HRMS sub-module of WBIFMS, West Bengal.

Resolution: The Executive Council of Vidyasagar University noted the Order bearing Memo No. 1180-F(Y) dated 23.03.2022 issued by the Joint Secretary to the Government of West Bengal, Finance Department, Audit Branch stating that eservices for Employees (eSE) facility has already been provided to the State Government Employees using which they can view and download Pay Slip, Income Tax Statement etc. Demand for extending the same facility to the employees (both teaching and non-teaching) of Universities, Grant-in-Aid Colleges and employees of other Grant-in-Aid institutions, drawing their Pay bill through HRMS, has been received by and was under active consideration of the Finance Department, Government of West Bengal from sometime past. Now, the Governor has been pleased to extend the e-Services for Employees (eSE) facility to all the teaching and non-teaching employees of Universities, Grant-in-Aid Colleges and employees of other Grant-in-aid institutions, drawing their Pay Bill through

HRMS sub-module of WBIFMS, West Bengal, so that they can also use the online facility for their benefit.

After thorough discussion on the letter received from the Finance Department of Government of West Bengal, Audit Branch regarding extension of 'e-Services for Employees' facility to teaching and non-teaching employees of Universities, Grant-in-Aid Colleges and employees of other Grant-in-aid Institutions, drawing their Pay Bill through HRMS sub-module of WBIFMS, West Bengal, it was resolved that the said Order of the Finance Department, Audit Branch be accepted and the Finance Officer of this University be requested to process further in this regard. Resolved further that a copy of the said order be forwarded to the colleges affiliated to the University for their information and the Inspector of Colleges of this University be requested to process further in this regard.

06(n) To place before the Executive Council of Vidyasagar University, the statement of Medical Leave in favour of Dr. Shamita Sarkar, Department of History of Vidyasagar University prepared and submitted by the Establishment Section of this University.

Resolution: The Executive Council of Vidyasagar University noted the detailed medical leave statement prepared by the Establishment Section of this University in favour of Dr. Shamita Sarkar, Associate Professor, Department of History of Vidyasagar University. The Executive Council noted also from the statement that Dr. Sarkar out of total 180 days full-pay medical leave (360 HPL) during her service life as per the leave norms of the University, 158 days full-pay medical leave (316 HPL) has already enjoyed till 05.02.2020 and the rest of 22 days full-pay medical leave (44 HPL) is credited to her leave account. The Executive Council noted further that Dr. Sarkar has lastly applied for medical leave already taken by her during the period from 06.12.2021 to 14.03.2022 for 99 days for the purpose of her treatment again.

After thorough discussion on the statement of Medical Leave in favour of Dr. Shamita Sarkar, Department of History of Vidyasagar University prepared and submitted by the Establishment Section of this University, it was resolved that the leave during the period from 06.12.2021 to 14.03.2022 taken by Dr. Sarkar for her medical treatment, out of total 99 days leave, 22 days leave be granted to her as medical leave with full-pay and the rest 77 days leave be granted to her as earned leave on medical ground. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

06(o) To consider the letter dated 25.04.2022 submitted by Shri Ananda Moy Sarkar, former Finance Officer of Vidyasagar University regarding legitimate payment of the balance amount during the tenure of his service under re-employment as per the relevant G.O. of the Finance Department, Audit Branch, Government of West Bengal.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 25.04.2022 submitted by Shri Ananda Moy Sarkar, former Finance Officer of Vidyasagar University alongwith the supporting documents stating that he was retired from the University on 31.01.2016 and after that he was re-employed on the post of Finance Officer at Vidyasagar University with effect from 01.01.20216 and continued upto 03.09.2018. In terms of the G.O. issued by the Finance Department, Audit Branch, Government of West Bengal from time to time, a re-employed employee should get his remuneration as Last Basic Pay plus DA as applicable from time to time plus HRA as applicable just before the retirement plus MA

minus basic pension before commutation plus Dearness Relief as applicable from time to time. But he was paid a consolidated amount per month which was far less than the admissible one. In this connection, Shri Sarkar has requested to consider his legitimate payment of the balance amount due in terms of the relevant G.O. of the Finance Department, Government of West Bengal.

After thorough discussion and careful consideration of the letter submitted by Shri Ananda Moy Sarkar, former Finance Officer of Vidyasagar University regarding legitimate payment of the balance amount during the tenure of his service under re-employment as per the relevant G.O. of the Finance Department, Audit Branch, Government of West Bengal, it was decided that the prayer of Shri Sarkar regarding payment of the balance amount during the tenure of his service under re-employment at Vidyasagar University as per the relevant G.O. of the Finance Department, Government of West Bengal be declined as it is not feasible at this point of time. Resolved further that the Registrar be requested to communicate the same to the incumbent concerned in this regard.

06(p) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/CDOE/D/99/2022 dated 25.04.2022 received from the Director, Centre for Distance and Online Education (CDOE) of Vidyasagar University regarding his opinion pertaining to payment of bill against the repeat order for PG Part-I SLMs printing of DDE without the approval of the then Vice-Chancellor.

Resolution: Consideration of the item was deferred.
