Resolution: The Executive Council of Vidyasagar University noted the letter dated 15.08.2021 submitted by Dr. Raj Kumar Kothari, Professor (On lien), Department of Political Science of Vidyasagar University stating that on account of some inadvertent mistakes committed by him for which he submitted an apology in writing to the then Hon'ble Vice-Chancellor underlining the fact that such mistakes would not occur in future but certain matters like 'charge sheet' and 'show cause' served him has been included in his Service Book at Vidyasagar University. Ashabul Khan, Senior Peon of Vidyasagar University seeking permission for resume of his duty with effect from 11.02.2022 and also grant him medical leave during the period from 14.12.2021 to 10.02.2022 taken by him for his operative treatment of Patella (Rt.), TBW.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 11.02.2022 submitted by Sk. Ashabul Khan, Senior Peon of Vidyasagar University alongwith the supporting medical documents stating that due to a motorcycle accident took place on 14.12.2021 he was suffering from Patella Fracture (Rt.), TBW and his operative treatment was done in this regard. He was medical treatment from 14.12.2021 to 10.02.2022 under an Orthopaedic Surgeon and now he is fit for light duty and accordingly praying for permitting him to resume his normal duties with effect from 11.02.2022. Institute of Medical Sciences from the academic session 2022-2023 with the affiliation of Vidyasagar University. They have already received the No Objection Certificate (NOC) from the Higher Education Department, Government of West Bengal for running such courses. At present they are conducting D. Pharm & B. Pharm courses. They also conduct different paramedical courses under the approval of the Directorate of Medical Education, Government of West Bengal and with the affiliation of the West Bengal University of Health Sciences. In this connection the Chairman has requested to grant affiliation to P.G. Institute of

Medical Sciences for introduction of different UG and PG courses from the academic session 2022-2023.

After thorough discussion on the letter submitted by the Chairman, P.G. Institute of Medical Sciences, Dhurabila, Dhumkuria, Chandrakona Town praying for granting of affiliation for introduction of different Postgraduate and Undergraduate courses at P.G. Institute of Medical Sciences from the academic session 2022-2023, it was resolved that a Committee be constituted to look into the matter and to suggest some measures in this regard. Resolved further that regarding nomination of persons to the Committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action.

06(m) To place before the Executive Council of Vidyasagar University, the letter dated 31.01.2022 received from Professor Ranjan Chakrabarti, Professor of History, Jadavpur University and former Vice-Chancellor of Vidyasagar University in reply to the decision taken by the Executive Council and communicated to him regarding the draft soft copy of the minutes of the meeting of the Executive Council of Vidyasagar University held on 30.06.2021 for his perusal and enable him to indicate the deviations and insertions.

Resolution: The Executive Council of Vidyasagar University noted that several requests regarding putting the signatures on the resolutions of the Sixth meeting of the Ninth Executive Council of Vidyasagar University held on 30.06.2021 alongwith the other three resolutions of the meetings (3rd, 4th & 5th) of the Ninth Executive Council of Vidyasagar University which were held under the Chairmanship of Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University and sent back the same to the University for uploading the University website, were made by the University to Professor Chakrabarti but we have not received the same from his kind end till date. The Executive Council noted also that lastly, the Ninth Executive Council of Vidyasagar University in its 9th meeting held on 22.12.2021 based on the letter dated 15.12.2021, 22.12.2021 & other related letter received from Professor Chakrabarti seeking the draft soft copy of the resolutions of the Sixth meeting of the Ninth Executive Council of Vidyasagar University held on 30.06.2021 to enable him to indicate the deviations and insertions, decided that the allegations made by Professor Chakrabarti regarding alleged deviations or insertions from the actual EC resolutions/decisions held on 30.06.2021 under his Chairmanship are found to be not substantial and hence are not accepted. So no changes/additions/alterations in the resolutions dated 30.06.2021 and duly confirmed by the Executive Council in its next meeting held on 25.08.2021 was done and it was prepared in letter and spirit. The EC also decided that Professor Chakrabarti is requested to honour the collective decision of the Executive Council taken in its meeting held on 30.06.2021 & confirmed on 25.08.2021 and to put his signatures on the resolutions alongwith the resolutions of the 3rd, 4th & 5th meetings of the Executive Council of Vidyasagar University respectively as Chairman and send the same to us either by messenger or by speed post as per his convenience immediately for uploading on the University website, the public domain of the University. The EC further requested to Professor Chakrabarti to refrain himself from making further acquisitions upon the University or its Registrar in this regard and such decisions taken by EC based on the complaints raised by Professor Chakrabarti in the matter of signature on the confirmed resolutions of the Sixth meeting of EC held on 30.06.2021 as Chairman be treated as the final & conclusive decision and no further communications be entertained from Professor Chakrabarti in this regard. Accordingly, the same was communicated to Professor Chakrabarti bearing our letter No. VU/R/9EC-

09/C0019/2022 dated 11.01.2022 for his kind perusal and in reply to that Professor Chakrabarti has submitted the above letter wherein he has deeply shocked, surprised and pained to read the content of the letter and the same is also deliberately insulted, humiliated, discredited, disrespected, malign and disown the remarkable achievements of the longest ever serving former Vice-chancellor of the University after his exit. Finally, he has put on record, for future reference, that he firmly stands by the points he mentioned in all his previous letters. The Executive Council was shocked as no insult or humiliation etc. has been caused to you as the former Vice-Chancellor of Vidyasagar University and that the former Vice-Chancellors always received high regard from the University. The Executive Council noted from your different correspondences specifically the last letter dated 31.01.2022 that you are not inclined to honour the collective decision of the Executive Council taken in its meeting held on 22.12.2021.

After thorough discussion on the letter dated 31.01.2022 received from Professor Ranjan Chakrabarti, Professor of History, Jadavpur University and former Vice-Chancellor of Vidyasagar University in reply to the decision taken by the Executive Council and communicated to him regarding the draft soft copy of the minutes of the meeting of the Executive Council of Vidyasagar University held on 30.06.2021, it was resolved that Professor Chakrabarti be requested again to kindly send back the signed copies of the confirmed resolutions of the 3rd (third), 4th (fourth), 5th (fifth) and 6th (sixth) Executive Council of Vidyasagar University held on 27.01.2021, 17.03.2021, 24.05.2021 & 30.06.2021 respectively to us immediately as the same are urgently required to be uploaded on the University website, the public domain as per the norms of the University. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

06(n) To consider the letter dated 11.03.2022 submitted by Ms. Bandana Sahoo, Junior EPABX Operator, Vidyasagar University praying for granting of Medical Leave during the period from 25.10.2021 to 27.02.2022 taken by her for suffering from post-operative weakness due to Hysterectomy Operation.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 11.03.2022 submitted by Ms. Bandana Sahoo, Junior EPABX Operator, Vidyasagar University along with the medical supporting documents praying for granting of medical leave during the period from 25.10.2021 to 27.02.2022 for 126 days taken by her for suffering from post-operative weakness due to Hysterectomy Operation.

After thorough discussion on the prayer submitted by Ms. Bandana Sahoo, Junior EPABX Operator, Vidyasagar University praying for granting of Medical Leave during the period from 25.10.2021 to 27.02.2022 taken by her for suffering from post -operative weakness due to Hysterectomy Operation, it was resolved that the out of the aforesaid leave of 126 days, full-pay medical leave during the period from 25.10.2021 to 20.01.2022 for 88 days and the Earned Leave on medical ground during the period from 21.01.2022 to 27.02.2022 for rest 38 days be granted to her as per the norms of the University for this purpose. Resolved further that the Registrar and the Establishment Section of this University be requested to process further regarding this.

06(r) To place before the Executive Council of Vidyasagar University, the report submitted by the Enquiry Committee constituted regarding inconsistencies in printing of Self-Learning Materials (SLMs) of the Centre for Distance and Online Education (CDOE).

Resolution: The Executive Council of Vidyasagar University noted the Eenquiry Report submitted by the Enquiry Committee constituted based on the complaints received regarding the anomalies of management of Aranyak Guest House at the Directorate of Distance Education (DDE) of Vidyasagar University. The said Report was placed before the Advisory Committee of the Centre for Distance and Online Education (CDOE) in its 160th meeting held on 21.03.2022 vide item No. 02(a) wherein the said report was read out & decided that the Enquiry Report be forwarded to the Executive Council of Vidyasagar University for further consideration. The Executive Council noted also that Shri Abhijeet Ghose was appointed as the Assistant Director of the Directorate of Distance Education (DDE) of Vidyasagar University, now renamed as the Centre for Distance and Online Education (CDOE) and he was additionally appointed a Part-time Resident Manager of Aranyak Guest House as additional charge with an additional monthly remuneration.

The Executive Council noted further from the said enquiry report as follows:

- (a) there are anomalies and discrepancies like financial, food quality, services and other related issues regarding the management of Aranayak Guest House.
 - (i) there are improper maintenance of accounts;
 - (ii) abnormal quantities of LPG cylinders used;
 - (iii) various bills produced by Shri Abhijeet Ghose were without particulars;
 - (iv) settlement of unadjusted advances;
 - (v) supply of poor quality of food;
 - (vi) serving of stale foods to the customers;
 - (vii) supply of packaged tiffin out of date;
 - (viii) non-maintaining of stock registers for non-consumable items regarding daily works and the hospitality served to the customers etc.etc.
- (b) Shri Ghose engaged the Guest House staff for his personal works.
- (c) He spent lots of time at Banani Lounge alongwith Dr. Misha Roy, Assistant Professor, Centre for Distance and Online Education (CDOE), the vendors and others.
- (d) Office/Guest House Staff were pressurized by Shri Ghose to collect the blank bills from different shops/stores.

(e) the enquiry committee recommends for taking every possible steps regarding the complaints as per the norms of the University to build a healthy system to run the Aranayak Guest House.

The Executive Council of Vidyasagar University further noted another Enquiry Report submitted by the Enquiry Committee constituted based on the complaints received regarding inconsistencies in PG Part-I SLMs printing and other related issues. The said Enquiry Report was placed before the Advisory Committee of the CDOE in its 160th meeting held on 21.03.2022 vide item No. 02(b) wherein the said report was read out & decided that the Enquiry Report be forwarded to the Executive Council of Vidyasagar University for further consideration. The Executive Council noted also from the said enquiry report as follows:

- (a) there are inconsistencies and anomalies like the paper quality, style of printing, quantity of printed materials, modes of delivery etc.;
- (b) the paper quality of the pages of the books, front and back cover, were not as per the specification and not at par with the work order issued for this purpose. Quality of paper and norms of standard style of printing of SLMs delivered to the students were a very poor quality and violating the specifications;
- (c) repeat work order issued to SKG Media, Kolkata which contained a much larger quantity of books to be printed than the earlier work order. The repeat work order meant a much higher bill of Rs.21,35,129.15 to the University while the earlier bills were at Rs.4,41,997.00 and 6,10,084.00 respectively.
- (d) the Executive Council noted further from the said report that the "Repeat Printing Order" though processed and signed by Shri Abhijeet Ghose, Assistant Director, DDE during the period of closure of the University offline classes in both regular and distance modes, the oddly enough the order for printing was received and handed over to the SKG Media at Calcutta by Shri Abhijeet Ghose, as is evident from the submission made by the Director (Officiating), DDE and Shri Rathindranath Chakraborty, Junior Superintendent of the University;
 - (e) the Director (Officiating), DDE signed the bill for payment alongwith the Finance Officer though the approval by the then Hon'ble Vice-chancellor regarding payment of the bill against the repeat order was essential under the DDE financial rules of the University. In respect of payment of previous bills the approval of the Hon'ble Vice-chancellor was obtained but in case of payment made to SKG Medical against repeat order the approval and signature of the then Hon'ble Vice-Chancellor was not obtained and the Director of DDE and the Finance Officer violated the DDE financial rules while they checked and passed a bill against the repeat order;
 - (f) it is further reported that shri Abhijeet Ghose played a very proactive role during the whole process. The undue haste and interest shown by Shri Ghose in handing over the work order to the Calcutta based printing firm and all the complaints directed against Shri Ghose of putting pressure on some of the employees reinforce fact of the complicity of Shri Ghose in the whole matter;
 - (g) the Enquiry Committee recommended for taking appropriate actions as per the Rules & Regulations of the University.

After thorough discussion on both the Enquiry Reports submitted by the duly constituted Enquiry Committee(s) regarding the anomalies of management of Aranyak Guest House at the Directorate of Distance Education (DDE) of Vidyasagar University & inconsistencies in PG Part-I SLMs printing and other related issues respectively, it was unanimously resolved as follows:

- (a) the enquiry report(s) submitted by the enquiry committee (s) duly forwarded by the Advisory Committee of the Centre for Distance and Online Education (CDOE) be accepted for further investigations;
- (b) necessary disciplinary proceedings duly recommended by the enquiry committee (s) be intiated against Shri Ghose and other related/named persons, if any, as per the norms of the University;
- (c) relevant portion of the Enquiry Report regarding violation of the DDE financial rules in case of payment of repeat order be sent to the Director (Officiating), CDOE and the Finance Officer of Vidyasagar University respectively for their perusal and opinion, if any, in this regard;
- (d) in the present situation, the resignation tendered by Shri Abhijeet Ghose from the post of Assistant Director of DDE is not accepted and be kept pending till finalisation of disciplinary proceedings.
- (e) the Registrar be requested to intimate the extract of such resolution to Shri Ghose in this regard.
 - (f) the Registrar be requested to process further regarding preparation of framing the charges upon Shri Abhijeet Ghose and other related/named persons in terms of the Enquiry Report and the same be placed before the next meeting of the Executive Council for consideration.
- O6(s) To place before the Executive Council of Vidyasagar University, the draft Annual Quality Assurance Report (AQAR) for 2020-2021 of Vidyasagar University.

 Resolution: The Executive Council of Vidyasagar University noted the detailed draft Annual Quality Assurance Report (AQAR) for 2020-2021 of Vidyasagar University prepared and submitted by the Director of Internal Quality Assurance Cell (IQAC) of this University. After thorough discussion on the Annual Quality Assurance Report, it was resolved that the said Annual Quality Assurance Report be accepted and the Director of IQAC be requested to process further in this regard.
 - 06(t) To note that the post of Deputy Librarian of the Central Library of Vidyasagar University is going to be vacant with effect from 1st June, 2022.

 Resolution: The Executive Council of Vidyasagar University noted that consequent upon superannuation of Shri Amiya Kumar Sarkar from the post of Deputy Librarian of Vidyasagar University with effect from 31.05.2022 on attaining the age of 65 (sixty-five) years, the post of Deputy Librarian of Vidyasagar University will remain vacant with effect from 1st June, 2022.

After thorough discussion on the matter regarding the vacancy to be created in the post of Deputy Librarian, Central Library of Vidyasagar University with effect from 1st June, 2022 consequent upon superannuation of Shri Amiya Kumar Sarkar on attaining the age of 65 (sixty-five) years, it was resolved that the post of Deputy Librarian of Vidyasagar University be declared as vacant with effect from 1st June, 2022 for this purpose and necessary steps as per the norms of the University for recruitment to the said post as a fresh be taken/initiated in this regard. Resolved further that the Registrar and the Establishment Section of this University be requested to process further regarding this.

In this connection he has prayed to the University for releasing him from his service at Vidyasagar University with retirement benefits from the afternoon of 31.03.2022.

After thorough discussion on the letter submitted by Dr. Siddhartha Sankar Dash, Medical Officer of Vidyasagar University praying for release him from the University as Voluntary Retirement with retirement benefits on and from the afternoon of 31.03.2022, it was resolved that Dr. Dash be released finally from the post of Medical Officer of Vidyasagar University as Voluntary Retirement with effect from the afternoon of 31st March, 2022 as prayed for by him in his letter dated 15.03.2022. Resolved also that the post-retirement benefits (pension) under voluntary retirement of Dr. Dash as also prayed for by him, the said benefits be released after getting clearance/concurrence from the Higher Education Department, Government of West Bengal as there is no such Provision for "Voluntary Retirement" at present in our Statute/Ordinances, decided by the Executive Council in its earlier meeting held on 22.12.2021 and communicated to him in this regard. Resolved further that the post of Medical Officer of Vidyasagar University be declared as vacant with effect from 1st April, 2022 for this purpose and necessary steps as per the norms of the University for recruitment to the said post as a fresh be taken/initiated in this regard. The Executive Council noted further that it has come to the notice of the University authority that different messages/official communications from different corners are coming through this mail in favour of the Hon'ble Vice-Chancellor of Vidyasagar University but we are unable to check/see such important messages/official communications regularly as it is password protected and the password is kept confidential with the then Hon'ble Vice-Chancellor, Professor Ranjan Chakrabarti till date although he has left the University after completion of his tenure as the Vice-Chancellor of Vidyasagar University.

After thorough discussion on the matter regarding using the e-mail Id: "vcvn.confidential@gmail.com" created by the University for urgent and confidential communications with the Hon'ble Vice-Chancellor of Vidyasagar University, it was resolved that Professor Chakrabarti be requested to inform/intimate the password of such e-mail to the Registrar of Vidyasagar University immediately so that the University may check/see the important

messages/communications coming from different corners in favour of the Hon'ble Vice-Chancellor regularly. Resolved further that the Registrar be requested to process further to convey the decision of the Executive Council to Professor Chakrabarti for the purpose of collection of the password of such e-mail immediately.

After thorough discussion on the letter jointly submitted by the Executive Director of Computer Centre and the former System Analyst of Vidyasagar University regarding the Electronic Gazette with the former Vice-Chancellor, Professor Ranjan Chakrabarti, for use of his office and residence, it was resolved that Professor Chakrabarti be requested to return back the instruments/materials of the University lying with him till date to the University immediately as all the instruments/materials are the property/asset of the University. Resolved further that the Registrar be requested to process further to communicate the decision of the Executive Council to Professor Chakrabarti in this regard.
