Resolution: The Executive Council of Vidyasagar University noted that in terms of the decision taken by the Ninth Executive Council of Vidyasagar University in its meeting held on 27.01.2021, the report of the Internal Complaints Committee(ICC) made on the basis of the complaint regarding sexual harassment lodged by a 4th semester girl student, namely, Ms. Renuka Singha Roy against Professor Paresh Chandra Jana, Department of Physics of Vidyasagar University, was communicated to Professor Jana for his observations/opinion. The Executive Council noted further the detailed observations/opinion submitted by Professor Jana, Department of Physics of Vidyasagar University bearing his letter dated 03.02.2021 based on the aforesaid enquiry report of the Internal Complaints Committee communicated to him.

After thorough discussion on the observations/opinion made by Professor Jana on the report of the Internal Complaints Committee regarding sexual harassment lodged by a 4th semester girl student of the Department of Physics of this University against him duly accepted by the Executive Council in its earlier meeting and communicated to him, it was resolved as follows:

- (i) the observations/opinion made by Professor Jana on the enquiry report of the Internal Complaints Committee are not satisfactory;
- (ii) a token punishment of freezing one annual increment be imposed against Professor Jana based on the enquiry report of the Internal Complaints Committee;
- (iii) a warning letter be issued in favour of Professor Jana stating not to repeat the practice of misbehaving to anybody in future and requesting him to behave properly to all as one of the Teachers of an educational institution;
- (iv) Professor Jana be requested to re-join his normal duties of the concerned Department at Vidyasagar University with immediate effect;
- (v) the leave during the period from 26.02.2020 till the date of his re-joining the duties at Vidyasagar University as was granted to him by the University for enquiry of the Internal Complaints Committee pertaining to above be treated as special leave;
- (vi) the Registrar be requested to communicate the same to the concerned incumbent immediately as decided by the Executive Council.

The Executive Council noted further that in reply to the letter of Professor Chakrabarti dated 07.09.2021 and as per the direction of the present Hon'ble Vice-Chancellor of Vidyasagar University, a letter bearing No.VU/R/C0268/2021 dated 14.09.2021 was issued to him alongwith the resolutions of the Sixth meeting of the Executive Council held on 30.06.2021 duly confirmed by the Executive Council in its Seventh (7th) meeting held on 25.08.2021 under the Chairmanship of the present Vice-Chancellor.

The Executive Council noted with surprise that the resolutions of other confirmed resolutions of three meetings, viz. Third (3rd), Fourth (4th) and Fifth (5th) of the Executive Council held on 27/01/2021, 17/03/2021 & 24/05/2021 respectively under Chairmanship of Professor Chakrabarti were not signed by him during his tenure though executive actions were taken thereon and those resolutions were also sent alongwith Registrar's letter dated 14.09.2021 for his signature as Chairman for uploading the same on public domain.

It was also informed to Professor Chakrabarti that since after his leaving on 05/07/2021, Professor Sibaji Pratim Basu assumed the Chair of Vice-Chancellor of Vidyasagar University with effect from 6th July, 2021. Prof. Sibaji Pratim Basu was a member of the Executive Council as Dean of the Faculty of Arts & Commerce and was present in the meeting of the Executive Council held on 30.06.2021 and in other earlier meetings too. He was a part of the decision-making process of the Resolutions of Sixth meeting of the Executive Council held on 30/06/2021. After holding the said meeting on 30/06/2021, many of the draft actions were prepared on the basis of the decisions taken by the Executive Council unanimously and the same were forwarded to Professor Chakrbarti in some phases for his kind approval. Unfortunately, the University received some of the decisions with necessary corrections / alterations from him and some decisions were not sent back by him resulting in various difficulties in execution of those decisions by the Vidyasagar University. As the University did not receive approval of the rest part of the Resolutions/Actions from his kind end, said draft Resolutions alongwith other actions taken on the basis of the resolutions of the Sixth meeting of the Executive Council of Vidyasagar University held on 30.06.2021 item-wise were placed before the present Hon'ble Vice-Chancellor and after getting approval from his kind end, necessary actions were taken.

The draft resolutions of the Sixth meeting of the Executive Council of Vidyasagar University were placed in the next (Seventh) meeting of the Ninth Executive Council of Vidyasagar University held on 25.08.2021 and the Resolutions of Meeting dated 30/06/2021 were confirmed under the Chairmanship of the present Vice-Chancellor of Vidyasagar University.

In this back-drop, the Executive Council noted again that in view of the letter dated 08.10.2021 received from Professor Chakrabarti through mail in reply to the letter dated 14.09.2021 issued by the Registrar of Vidyasagar University and after thorough discussion on various correspondences received from Professor Ranjan Chakrabarti, Former Vice-Chancellor of Vidyasagar University and subsequent reply made by the University regarding signatures on the resolutions of the meetings of the Executive Council of Vidyasagar University held under his Chairmanship during his tenure at Vidyasagar University, it was resolved unanimously as follows:

- (a) The Executive Council found no substance and hence, could not accept the allegations of Professor Chakrabarti that he found several deviations from the actual EC resolutions/decisions adopted or arrived at the meeting of the Executive Council held on 30.06.2021 or that new insertions have been made in the said resolutions or that resolutions adopted in the meeting of the Executive Council held on 30.06.2021 under his Chairmanship have been modified.
- (b) The Resolutions of the Sixth (6th) meeting of the Ninth Executive Council of Vidyasagar University held on 30.06.2021 as was sent to Professor Chakrabarti for his signature was the verbatim representation/reproduction as it was taken in the meeting held on 30.06.2021 and confirmed unanimously by all members of the Executive Council of Vidyasagar University in its Seventh (7th) meeting held on 25.08.2021.
- (c) The contents of the letter dated 08.10.2021 received from Professor Chakrabarti through mail in reply to the letter dated 14.09.2021 sent by the University regarding alleged modifications/corrections of the resolutions of the Sixth meeting of the Ninth Executive Council of Vidyasagar University was not tenable and hereby could not be approved.

- (d) The Registrar of Vidyasagar University be requested to send this decision of the Executive Council taken based on his reply letter dated .08.10.2021 to Prof. Chakrabarti and to request him to put his signature on the resolutions of the Sixth meeting of the Ninth Executive Council held on 30.06.2021 duly confirmed by the EC in its meeting held on 25.08.2021 and send back to the University immediately for uploading the same in public domain.
- (e) Professor Chakrabarti be also requested to put his signatures on the resolutions of Third (3rd), Fourth (4th) and Fifth (5th) meetings of the Ninth Executive Council of Vidyasagar University held on 27/01/2021, 17/03/2021 & 24/05/2021 respectively & confirmed in the consecutive next meeting of Executive Council, both held under his Chairmanship and send back the same to the Registrar of the University immediately for uploading the same in public domain alongwith the signed resolutions of the Sixth meeting of the Ninth Executive Council of Vidyasagar University.
- (f) The Registrar be requested to process further in this regard as decided by the Executive Council.
- 05(g) To consider the letter dated 27.08.2021 submitted by Shri Samiran Maity, former Junior Peon of Vidyasagar University praying for joining his usual duties as a Junior Peon in the University as expeditiously as possible.

Resolution: The Executive Council of Vidyasagar University noted that Shri Samiran Maity joined Vidyasagar University as Junior Peon. After his joining he was absent continuously from his duties. He was issued several reminders for his re-joining and lastly based on his prayer he was directed to join positively by 15.06.2021 but he failed to join. In terms of the decision taken lastly by the Executive Council in its Sixth meeting held on 30.06.2021, he was terminated from the post of Junior Peon of Vidyasagar University and his name was also struck off from the Rolls as he didn't report his duties within the stipulated date fixed by the Executive Council in its meeting dated 24.05.2021. Accordingly, the decision of EC was communicated to him for this purpose. The Executive Council noted further that in reply to that Shri Maity has submitted a letter dated 27.08.2021 praying for joining his usual duties at Vidyasagar University as expeditiously as possible.

After thorough discussion on the letter submitted by Shri Samiran Maity, former Junior Peon of Vidyasagar University praying for joining his usual duties as a Junior Peon in the University as expeditiously as possible, It was resolved that the legal opinion for the aforesaid matter be sought for and further action in the matter may be taken after receiving the legal opinion in this regard. Resolved further that the Registrar be requested to process further in this regard.

- 05(h) To consider the letter dated 02.09.2021 submitted by a group of teachers engaged in Vidyasagar University purely on contractual manner praying for extension/renewal of service period of contractual teachers upto the age of 65 years.
 - Resolution: The Executive Council of Vidyasagar University noted that a group of teachers engaged in Vidyasagar University at various departments purely on contractual manner have jointly submitted the above mentioned letter stating that they have been fully engaged in teaching, evaluation, research and other administrative assignments since their joining. Besides this, they have been actively involved in various other responsibilities particularly in connection with UGC Team visit, NAAC Peer Team visit, Inter-University National Youth

Festival, Inter-University athlete meet etc. and also participated and organised seminars, symposia & workshops etc. like substantive teachers. In this connection they have requested to extend or renewal of their services upto the age of 65 years in relevance with the superannuation age of substantive teachers of state-aided colleges and universities.

After thorough discussion on the letter submitted by a group of teachers engaged in Vidyasagar University purely on contractual manner praying for extension/renewal of service period of contractual teachers upto the age of 65 years, it was resolved that only the service period of the concerned teachers of this University be extended/renewed upto the age of sixty-five(65) years in relevance with the superannuation age of the substantive teachers as the teachers concerned have been performing various responsibilities like substantive teachers of the University but the terms & conditions of such service will remain same as stipulated/notified by the University and to be decided by the University further from time to time which will be communicated in due course of time. Resolved further that the Registrar be requested to process further in this regard.

05(i) To place before the Executive Council of Vidyasagar University, the Order bearing No. 222L/OM-86L/2020 dated 27.10.2021 received from the Deputy Secretary to the Government of West Bengal, Higher Education Department regarding No Objection for introduction of additional courses in the P.G. Institute of Medical Sciences from the academic session 2021-2022 under affiliation of Vidyasagar University.

Resolution: The Executive Council of Vidyasagar University noted the Order bearing No. 222L/OM-86L/2020 dated 27.10.2021 issued by the Deputy Secretary to the Government of West Bengal, Higher Education Department, a copy of which was forwarded to us for our information, stating that considering the proposal submitted by the P.G. Institute of Medical Sciences seeking No Objection from the State Government for introduction of some additional courses which are mostly professional having higher employability quotient, the Governor is hereby, pleased to allow the said institution for introduction of the said courses from the academic session 2021-2022 under the affiliation of Vidyasagar University fulfilling the terms & conditions of affiliation to be provided by the affiliating University and charging the course fee similar to that of other self-financing course fees etc.

After thorough discussion on the order received from the Deputy Secretary to the Government of West Bengal, Higher Education Department regarding No Objection for introduction of additional courses in the P.G. Institute of Medical Sciences from the academic session 2021-2022 under affiliation of Vidyasagar University, it was resolved that an Inspection Team be constituted to visit the concerned institute and to see all aspects for this purpose and also to submit a detailed report in this regard for further consideration of the Executive Council. Resolved further that regarding nomination of members to the Inspection Team, the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved again that the Inspector of Colleges of this University be requested to process further in this regard.

05(j) To place before the Executive Council of Vidyasagar University, the Order bearing No. 221L/OM-86L/2020 dated 27.10.2021 received from the Deputy Secretary to the Government of West Bengal, Higher Education Department regarding issuing of No Objection for introduction of additional courses in the Midnapore City College from the academic session 2021-2022 under affiliation of Vidyasagar University.

<u>Resolution:</u> The Executive Council of Vidyasagar University noted the Order bearing No. 221L/OM-86L/2020 dated 27.10.2021 issued by the Deputy Secretary to

the Government of West Bengal, Higher Education Department, a copy of which was forwarded to us for information, stating that considering the proposal submitted by the Midnapore City College seeking No Objection from the State Government for introduction of some additional courses which are mostly professional having higher employability quotient and based on the Inspection report constituted for this purpose, the Governor is hereby, pleased to allow the said institution for introduction of the said courses from the academic session 2021-2022 under the affiliation of Vidyasagar University fulfilling the terms & conditions of affiliation to be provided by the affiliating University and charging the course fee similar to that of other self-financing course fees etc.

After thorough discussion on the order received from the Deputy Secretary to the Government of West Bengal, Higher Education Department regarding issuing of No Objection for introduction of additional courses in the Midnapore City College from the academic session 2021-2022 under affiliation of Vidyasagar University, it was resolved that resolved that an Inspection Team be constituted to visit the concerned institute and to see all aspects for this purpose and also to submit a detailed report in this regard for further consideration of the Executive Council. Resolved further that regarding nomination of members to the Inspection Team, the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved again that the Inspector of Colleges of this University be requested to process further in this regard.

05(k) To consider the letter dated 08.10.2021 submitted by Dr. Subal Chandra Manna, Associate Professor, Department of Chemistry of Vidyasagar University praying for granting of earned leave on special ground during the period from 01.09.2021 to 07.10.2021 taken by him for the purpose of treatment of his younger brother.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 08.10.2021 submitted by Dr. Subal Chandra Manna, Associate Professor, Department of Chemistry of Vidyasagar University alongwith the supporting medical documents stating that due to suffering from adenocarcinoma, rectum of his younger brother he was stayed with him at Mumbai for his immediate treatment and for this reason he was unable to attend his duties from 01.09.2021 to 07.10.2021. In this connection he has requested to grant him earned leave for special ground for the aforesaid days for this purpose.

After thorough discussion on the letter submitted by Dr. Subal Chandra Manna, Associate Professor, Department of Chemistry of Vidyasagar University praying for granting of earned leave on special ground during the period from 01.09.2021 to 07.10.2021 taken by him for the purpose of treatment of his younger brother, it was resolved that Dr. Manna be granted Earned Leave during the period from 01.09.2021 to 07.10.2021 taken by him for the purpose of treatment of his younger brother as a special case. Resolved further that Dr. Manna be also requested not to repeat such practice in future and to apply/inform the University well in advance for taking such type of leave for approval. Resolved again that the Registrar & the Establishment Section of this University be requested to process further in this regard.

05(l) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/CE/237/2021 dated 01.11.2021 submitted by the Controller of Examinations of Vidyasagar University regarding formulation of Standard Operating Procedure (SOP) for issuing of duplicate degree/diploma certificates.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. VU/CE/237/2021 dated 01.11.2021 submitted by the Controller of Examinations of Vidyasagar University stating that his department receives a lot of applications for issuing of duplicate degree/diploma certificates due to various reasons but the same are not issued in due course of time and the process for issuing the same is delayed due to absence of signatures and seals of the former Vice-Chancellors. To overcome the delay process for issuing the same, a Standard Operating Procedure (SOP) may be formulated. He has proposed that a revision of SOP regarding putting the signature & stamp of the present Vice-Chancellor with current date on such certificates retaining the exact date of Convocation and marked duplicate at the top of the certificate may be issued.

After thorough discussion and careful consideration of the proposal submitted by the Controller of Examinations regarding formulation of Standard Operating Procedure (SOP) for issuing of duplicate degree/diploma certificates, it was resolved that the revised Standard Operating Procedure (SOP) regarding putting the signature & stamp of the present Vice-Chancellor with current date on such certificates /diplomas retaining the exact date of Convocation as proposed by the Controller of Examinations be approved but the concerned Certificates/Diplomas be marked as True Copy in place of Duplicate at the top of the Certificates/Diplomas to overcome the delay processes. Resolved further that the Controller of Examinations of this University be requested to process further in this regard.

05(m) To place before the Executive Council of Vidyasagar University the matter regarding issuing an Office Order pertaining to permitting Shri Ashimava Praharaj, Accounts Officer of this University to look after the work of the Audit Officer of this University in addition to his normal duties for a period of six months or until further order, whichever is earlier, with effect from 1st November, 2021 and also permitting Sk. Ali Hossain, Accountant & Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I of this University to assist the Accounts Officer in discharging the Accounts Officers' role in additional to their normal duties for a period of six months with effect from 1st November, 2021 or until further order whichever is earlier.

Resolution: The Executive Council of Vidyasagar University noted that as per kind direction of the Hon'ble Vice-Chancellor, Shri Ashimava Praharaj, Accounts Officer of this University may be permitted to look after the work of the Audit Officer of this University in addition to his normal duties for a period of six months or until further order, whichever is earlier, with effect from 1st November, 2021 and also Sk. Ali Hossain, Accountant & Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I of this University may also permitted to assist the Accounts Officer in discharging the Accounts Officers' role in addition to their normal duties for a period of six months with effect from 1st November, 2021 or until further order whichever is earlier. An office order in this regard may kindly be issued.

After thorough discussion on the proposal submitted by the office of the Registrar regarding looking after the office of the Audit Officer of Vidyasagar University, who is at present on lien, it was resolved that the following employees of this University be permitted to look after the responsibilities, specified against each of the incumbents concerned in addition to their normal duties at Vidyasagar University for a period of six (06) months or until further order whichever is earlier with immediate effect.

- (i) Shri Ashimava Praharaj, Accounts Officer of Vidyasagar University be permitted to look after the work of Audit Officer of Vidyasagar University.
- (ii) Shri Proloy Kumar Ghosh, Technical Assistant Gr.-I of Vidyasagar University be permitted to assist the Accounts Officer in discharging the Accounts Officers' role.
- (iii) Sk. Ali Hossain, Accountant of Vidyasagar University be permitted to assist the Accounts Officer in discharging the Accounts Officers' role.

Resolved further that the Finance Officer of this University be requested to distribute the works amongst the incumbents concerned as stated herein above.

05(n) To consider the letter bearing No. VU/Physio/Dean Sciences/1282/2021 dated 01.11.2021 submitted by Dr. Chandradipa Ghosh, Professor, Department of Human Physiology of Vidyasagar University praying for granting of Child Care Leave from 18.11.2021 to 10.12.2021 to provide the support of her son for final examination.

Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. VU/Physio/Dean Sciences/1282/2021 dated 01.11.2021 submitted by Dr. Chandradipa Ghosh, Professor, Department of Human Physiology of Vidyasagar University alongwith the supporting documents praying for granting her Child Care Leave during the period from 18.11.2021 to 10.12.2021 for twenty four (24) days for care of his son Suchitrak Bandyopadhyay, who is going to be appeared before the final Board examination of class X commencing from November 20, 2021 from South Point School, Kolkata.

After careful consideration of the letter submitted by Professor Chandradipa Ghosh, Department of Human Physiology of Vidyasagar University praying for granting of Child Care Leave from 18.11.2021 to 10.12.2021 to provide the support of her son for final examination, it was resolved that the said Child Care Leave as prayed for by her be granted to her for this purpose. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

05(o) To place before the Executive Council of Vidyasagar University, the Police Verification Report (PVR) of VR received from the Superintendent of Police, DIB, Paschim Medinipur in favour of Shri Bivash Mahapatra, Laboratory Attendant Gr. - III of Vidyasagar University.

Resolution: The Executive Council of Vidyasagar University noted that the Ninth Executive Council of Vidyasagar University in its meeting held on 30.06.2021 confirmed the service of Shri Bivash Mahapatra as Laboratory Attendant Gr.-III of Vidyasagar University with effect from his date of joining the post, i.e. from the forenoon of 12.06.2020 subject to receiving of positive and successful antecedents from the competent authority. The Executive Council noted also that now we have received the Police Verification Report of VR bearing communication vide Memo No. D.R.1518 dated 24.09.2021 from the Superintendent of Police, DIB, Paschim Medinipur in favour of the incumbent concerned. The Executive Council noted further that the antecedents are verified by the competent authority and there is no objection against him.

After thorough discussion on the Police Verification Report (PVR) of VR received from the Superintendent of Police, DIB, Paschim Medinipur in favour of Shri Bivash Mahapatra, Laboratory Attendant Gr.-III of Vidyasagar University without any objection and subsequently the decision taken by the EC in its earlier meeting, the Registrar and the Establishment Section of this University be

requested to issue an office order regarding his confirmation of service as per the norms of the University immediately.

Resolved further that the Finance Officer of this University be requested to process further in this regard.
