Professor Ujjayan Bhattacharyya, Shri Goutam Chando Roy and Dr. Debjani Das, who proposed key modifications. The Executive Council further noted that as per the legal opinion, since the resolution of a Departmental

Committee, being a recommendation, adopted unanimously and minuted with signatures by all faculty members, the same may be deemed to be taken as final and as such, there could not be any scope for registering dissent/proposing modifications in subsequent meeting at the time of confirmation. There was a procedural lapse in the manner the dissent was expressed and minuted. This is not legally tenable.

After thorough discussion on the matter regarding finalization of specialization for appointment to the said post of Vidyasagar University Chair Professor created by the Higher Education Department, Government of West Bengal, University branch based on the decisions of the Departmental Committee and subsequently the legal opinion received by the University regarding the recording of dissenting opinion of three faculty members of the Department of History proposing the key modifications during confirmation of the minute of the Departmental Committee in its meeting held on 02.01.2019, it was resolved as follows :

- (1) the resolution unanimously taken by all the faculty members of the Department of History in its meeting held on 26.12.2018 duly signed by all the 7(seven) Faculty members of the department be treated as token of agreement, acceptance and approval.

- (4) the dissent was expressed and minuted in subsequent meeting during confirmation be treated as a procedural lapse of the Departmental Committee.
- (5) noted also that the four faculty members have already withdrawn themselves from this recording of the dissent during confirmation.
- (6) the note of dissent with regard to the Resolution dated 26.12.2018, given by 03(three) out of the 07 (seven) faculty members in subsequent meeting of the Departmental Committee held on 02.01.2019 is not legally tenable.
- (7) the Head of the Department concerned be requested to take care in future to avoid such procedural lapses in case of taking the decisions or confirmation of the Departmental Committee resolution.
- (8) the Head of the Department concerned be requested also to kindly rectify the procedural lapse in the next meeting of the Departmental Committee in this regard and withdraw the dissent by adopting an appropriate resolution.



Resolved further that a letter be sent to the Higher Education Department, Government of West Bengal for sanctioning the fund required for the said project and for immediate execution of the work in this University, out of the total fund, 50% (fifty percent) of the fund from the University and rest 50% (fifty percent) from the Directorate of Distance Education (DDE) of this University be utilized through the Finance Committee and the Advisory Committee of DDE of this University respectively.

After careful consideration of the letter submitted by the Chairman and Director, Eastern Institute for Integrated Learning in Management (EIILM), Kolkata pertaining to permission for registration of three students for admission into 2-year full-time M.B.A. programme of Vidyasagar University and also sit for first semester examination for the academic session 2018-2019, it was resolved that the said three numbers of student, namely, Saheli Bose, Aniket Choudhury and Shoaib Ali Ahmed those who have got below 40% marks in undergraduate level, for admission into MBA Programme as prayed for by the Chairman and Director of EIILM in its aforesaid letter be permitted to register themselves in this University for the academic session 2018-2019 provided that an amount of Rs.1,000/- (Rupees one thousand) only per candidate is to be deposited to the University by the concerned institute as penalty for this purpose.

Icon Controls of India regarding malpractices in relation with electrical cable laying works from augmented electrical substation to central library annex building of Vidyasagar University.

Icon Controls of India regarding malpractices in relation with electrical cable laying works from augmented electrical substation to central library annex building of Vidyasagar University. The Executive Council also noted from the said enquiry report that two (02) Nos. of 185 sq.mm., 1.1KV grade, 3.5 Core, XPLE cable were laid down in a single trench of 920 mm wide instead of two (02) trenches each of 460 mm wide. Out of 477.6 meter cable laying, 25.2 meters is laid through existing trench and 452.4 meter cable was laid in new excavated and constructed trenches.

After thorough discussion on the enquiry report, it was resolved that the report submitted by the one-man enquiry committee regarding malpractices in relation with electrical cable laying works from augmented electrical substation to central library annex building of Vidyasagar University be accepted. Resolved also that the bill amount for the said cable laying work be released to the concerned vendor further retainment of 10% of the bill value apart from the Security Deposit. Resolved further that the said report be placed again after closure scrutiny of the same and after completion of such process, final settlement of the bill for the aforesaid work will be made by the University. Resolved again that the Registrar & the Finance Officer of this University be requested to do the needful in this regard at the earliest.
