





After careful consideration of the letter submitted by Dr. Gautam Pal, Finance Officer of Vidyasagar University praying for providing the financial benefit of salary from 01.09.2018 to 03.09.2018, it was resolved that three days salary of Shri Pal as prayed by him be released to him subject to approval of the Higher Education Department, Government of West Bengal. Resolved further that the Registrar be requested to write a letter to the Higher Education Department, Government of West Bengal seeking their approval in this regard at an early date.

- 05(e) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 20.11.2018 prepared by the office of the Registrar pertaining to submission of a proposal for holding the Annual Convocation of Vidyasagar University on the "University Foundation Day", i.e. 29th September in every year.

Resolution: The Executive Council of Vidyasagar University noted the Note Sheet dated 20.11.2018 prepared by the office of the Registrar stating that as per the present practice of the University, the Annual Convocation of Vidyasagar University is held on a date proposed by the University and duly assented by His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University since its inception. The Executive Council also noted that the Convocation of a University, like Vidyasagar University, is a very prestigious and glorious programme where the valuable degrees are conferred annually to its beloved passed out students in presence of different distinguished personalities, renowned persons etc. by His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University. As Convocation is a very prestigious occasion of a University, it may be held on an important day of the University. In connection with the above, it is proposed that the Annual Convocation of Vidyasagar University may be held on its "Foundation Day", i.e. 29th September in every year hereafter like some other Universities subject to kind assent of His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University.

After thorough discussion on the proposal submitted by the office of the Registrar of Vidyasagar University regarding holding the Annual Convocation of Vidyasagar University on the "University Foundation Day", i.e. 29th September in every year, it was resolved that the Annual Convocation of Vidyasagar University may be held on "Foundation Day" of Vidyasagar University, i.e. 29th September every year henceforth subject to kind assent of His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University. Resolved further that the Hon'ble Vice-Chancellor shall bring this matter to His Excellency the Governor of West Bengal and the Hon'ble Chancellor of Vidyasagar University for his kind assent in this regard.

- 05(f) To consider the letter dated 14.11.2018 submitted by Dr. Nivedita Bhattacharyya Sahu, Assistant Professor, Department of Library and Information Science of this University pertaining to granting of Maternity Leave for six months with effect from 04.12.2018.

Resolution: The Executive Council of Vidyasagar University noted the letter dated 14.11.2018 submitted by Dr. Nivedita Bhattacharyya Sahu, Assistant Professor, Department of Library and Information Science of this

*University praying for availing six months Maternity Leave with effect from 04.12.2018 as her expected date of delivery is 25.12.2018.*

*Resolution: The Executive Council of Vidyasagar University noted the letter bearing No. BIBS/384/18-19/R/EX dated Nil submitted by the Principal of Bengal Institute of Business Studies (BIBS), Kolkata stating that at present the candidature of 60 Nos. of student are on hold since they have less than the requisite percentage of marks in graduation but have passed from their respective universities. Many of the students of our state are moving to other states for availing the job oriented courses due to non-fulfillment of the requisite percentage of marks. Students are helpless in the current difficult economic conditions and would find it extremely challenging to gain employment without a post-graduate degree. In this connection he has requested to consider these students and allow them to pursue the said programme and also register themselves in this University for this purpose*

*After thorough discussion on the letter submitted by the Principal of Bengal Institute of Business Studies (BIBS), Kolkata praying for registration of the students having less than 45% marks in aggregate in undergraduate level for admission into the regular M.B.A. programme run by the BIBS, it was resolved that the students concerned having less than 45% marks in aggregate in undergraduate level for admission into the regular M.B.A. Programme of Vidyasagar University run by them may be permitted to register themselves in this University as a special case on case to case basis subject to deposition of an amount of Rs.500/- (Rupees five hundred) only per student to the University as penalty.*

- 05(h) To place before the Executive Council of Vidyasagar University, the enquiry report submitted by one-man enquiry committee constituted for various issues of irregularities and/or inefficiency of Shri Subhas Chandra Maiti, Deputy Controller of Examinations of Vidyasagar University.

In this connection he has requested to furnish the statistical information in respect of teaching and non-teaching as well as admissions*

*to all level courses and hostel accommodation during he 2018-2019 in the format prescribed by the UGC.*






