The Executive Council also noted that as per the advertisement bearing Employment Notification No. VU/R/Advt./01/01 dated 27.10.2001 made by the University for the post of Lecturer in the Department of Bengali of this University, the said post was reserved for SC community and Dr. Mandal applied for this particular post claiming himself as a Scheduled Caste (Bhuimali) community. But Dr. Mandal belongs to the Chain Community which was not listed as a SC when Dr. Mandal applied for the said post of Lecturer in Bengali and he obtained the Scheduled Caste Certificate in 1989 by false means/forgery/misrepresentation or by exercising fake documents from the appropriate authority.

The Executive Council further noted that Dr. Mandal committed certain serious irregularities by using a forged / false caste certificate No.2536 dated 14.09.1989 for obtaining the post of Lecturer, Department of Bengali of Vidyasagar University and he obtained the said job in a fraudulent manner. After thorough discussion on the enquiry report submitted by the One-man Enquiry Committee regarding the Charge-sheet issued against Dr. Santosh Kumar Mandal, Lecturer (under suspension), Department of Bengali of Vidyasagar University, it was resolved as follows:

- (1) The Enquiry Report submitted by the One-man Enquiry Committee upon the Chargesheet issued to Dr. Santosh Kumar Mandal, Lecturer, Department of Bengali of this University, now under suspension be accepted.
- (2) In view of the Enquiry Report of the One-man Enquiry Committee, the charges framed against Dr. Santosh Kumar Mandal regarding obtaining the appointment by exercising fraud and by submitting forged caste certificate is proved.
- (3) Dr. Santosh Kumar Mandal be Terminated from his service as Lecturer, Department of Bengali of this University with immediate effect.
- (4) The subsistence allowance and other benefits which has been continuing in favour of Dr. Mandal as per the norms of the University during suspension be stopped with immediate effect.
- (5) The order of termination of service from the University entails forfeiture of all future benefits including post-retirement benefits to Dr. Mandal.
- (6) The total amount received by Dr. Mondal from this University since his joining as Lecturer in the Department of Bengali till date be recovered from Dr. Mandal as his appointment to the said post was illegal and obtained by exercising fraud.
- (7) A FIR be lodged in the local police station against Dr. Mandal for obtaining the service at Vidyasagar University by exercising fraud and by submitting forged Scheduled Caste Certificate declaring himself as Bhuimali Community although he belongs to Chain community.
- (8) The said post of Lecturer now re-designated as Assistant Professor in the Department of Bengali be declared as vacant for recruitment as

a afresh as per the norms of the University. For nomination of Subject Experts in the Selection Committee for recruitment of the said post, the matter be left to the Hon'ble Vice-Chancellor of this University for necessary action.
