Under this circumstances, in terms of Section 9 of the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2013 University authorities may fill-up the said vacant reserve seats by General Candidates by De-reservation of those seats (if available) after following due process for filling up of those reserve seats by the candidates of the specific categories but not getting any suitable candidate of the reserved categories to fill up those seats. No vacant reserved seat may be carried forward to the next academic year under any circumstances.

After thorough discussion on the Circular issued by the Deputy Secretary, Department of Higher Education, Science & Technology and Biotechnology, University Branch pertaining to de-reservation of Reserved seats for admission to all the Universities, it was resolved that the vacant reserve seats be filled-up by General Candidates by De-reservation of those seats (if available) after following due process for filling up of those reserve seats by the candidates of the specific categories as advised by the Higher Education Department. Resolved also that the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to do the needful in this regard.

Resolved also that the Inspector of Colleges of this University be requested to send the said Holiday List of Vidyasagar University to all colleges affiliated to Vidyasagar University for their information & follow up. Resolved further that the Inspector of Colleges of this University be also requested to send a letter to all colleges affiliated to Vidyasagar University requesting for opening the college after Laxmi Puja henceforth.

06(b) To place before the Executive Council of Vidyasagar University, the letter dated 12.10.2017 along with the draft MoU submitted by the Head, Department of Zoology, Vidyasagar University pertaining to sharing a common desire to explore, extend and strengthen the functional relationship between the Universities and National Organizations in order to share the facilities and expertise available with each of them.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed note dated 10.10.2017 prepared and submitted by the Establishment Section of Vidyasagar University regarding the admissible leave balance of Dr. Siddhartha Sankar Dash, Medical Officer of Vidyasagar University. The Executive Council also noted that his Earned Leave balance admissible in his leave account up to the year 2017 is 252 (two hundred fifty two) days out of this he was granted 55 (fifty five) days earned leave for his higher study. The Executive Council noted further that Dr. Dash availed 243 (two hundred forty three) days earned leave for this purpose again and he availed the excess earned leave of forty six (46) days. After thorough discussion on the note put forwarded by the Establishment Section of Vidyasagar University regarding the admissible leave balance of Dr. Siddhartha Sankar Dash, Medical Officer of Vidyasagar University, it was resolved that the excess forty six (46) days of leave taken by Dr. Dash be granted to him as advance from the earned leave which will be

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 15.10.2017 submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor in the Department of English, now under suspension, regarding her supplementary reply on the enquiry report submitted by the Enquiry Officer in respect of the Charge Sheet dated 03.11.2016 issued to her based on the decisions taken by the Executive Council of Vidyasagar University in its meeting held on 28.08.2017. The Executive Council also noted that the reply letter dated 13.08.2017 on the enquiry report and the aforesaid supplementary reply on the enquiry report submitted by her are self-contradictory. The Executive Council further noted that Dr. Datta (Chaudhuri) left the station without the permission of the University authority.*

*After thorough discussion on the supplementary reply letter submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University, now under suspension, it was resolved that the said supplementary reply on the enquiry report be not accepted as both the replies in this regard are self-contradictory. Resolved also that the matter be clubbed with the Internal Complaint Cell (ICC) and necessary disciplinary proceedings against her be continued.*

- 06(e) To place before the Executive Council of Vidyasagar University, the letter dated 11.10.2017 received from Professor Falguni Chakraborty, former Professor of the Department of Anthropology of Vidyasagar University through e-mail pertaining to his reply on the letter issued by the University authority regarding observations on the enquiry report.

&

- 06(f) To place before the Executive Council of Vidyasagar University, the letter dated 02.11.2017 received from Professor Falguni Chakraborty, former Professor, Department of Anthropology of Vidyasagar University through mail pertaining to demand for apology for authoring, publishing and circulating defamatory statements against Falguni Chakraborty.

**Resolution:** *The Executive Council of Vidyasagar University noted the letters dated 11.10.2017 & 02.11.2017 submitted by Professor Falguni Chakraborty, former Professor, Department of Anthropology of Vidyasagar University through e-mail seeking the name and other details of the Enquiry Officer and also demanding apology from the Registrar before him and the members of the Executive Council and publish the same in the University website. These letters were sent in response to the decisions taken by the Executive Council of Vidyasagar University in its meeting held on 21.09.2017 and communicated to him vide letter No. VU/R/SEC-11/C0435/2017 dated 10.10.2017. The Executive Council also noted the contents of two letters (date-wise) submitted by Professor Chakraborty as follows :*

Letter dated 11.10.2017 :

- (i) Professor Falguni Chakraborty refuted the jurisdiction of any authority of Vidyasagar University.
- (ii) He challenged the wisdom and authority of the Executive Council and also the enquiry officers' report although he has not referred to the evidences or depositions based on which the report was prepared.
- (iii) He defamed the Vidyasagar University authority by claiming that the enquiry report is false, motivated and defamatory in nature.
- (iv) He threatened Dr. J.K. Nandi, the Registrar of Vidyasagar University, who is a public officer/servant and discharges his duties as per the statutory provisions, guidelines, rules and regulations of Vidyasagar University and he is incharge of recording, printing, publishing or circulating all documents as per rules.
- (v) He also threatened the Enquiry Officer mentioning that he will see him before court of law although he couldn't prove that the report was false.

Letter dated 02.11.2017 :

- (i) Professor Falguni Chakraborty claimed that the enquiry report contains a false, motivated and defamatory imputations to harm and defame him. It is totally wrong as he has not referred to the evidences or depositions based on which the report was prepared.
- (ii) He threatened Dr. J.K. Nandi, Registrar of Vidyasagar University demanding that the latter must apologize before him, Members of Executive Council and also publish the same in the Website of Vidyasagar University although he could not do that without any proof. It manifests his ill intention to malign and defame Dr. Nandi personally and the Vidyasagar University Authority including the Hon'ble members of the Executive Council of Vidyasagar University.
- (iii) Dr. J.K. Nandi, Registrar of this University only read out the letter before the Executive Council as Secretary of the Executive Council and he did not circulate it among the members.
- (iv) Noted that he defamed Dr. J.K. Nandi, Registrar of this University and also the Vidyasagar University authority by circulating his aforesaid letter to other public.

The Executive Council of Vidyasagar University further noted that as no interim EC was held between 12.10.2017 and 05.11.2017, the question of any response to Professor Chakraborty regarding his aforesaid letters did not arise. Resolved that the association or presence of such a belligerent person having no respect, allegiance or loyalty to the University he served under and its legitimate sitting Vice-Chancellor appointed by the Hon'ble Chancellor or the legitimate members of the Executive Council or its Secretary, the Registrar, which also includes nominees of the Hon'ble Chancellor, is not conducive to the academic environment of this or any other academic institutions. The Executive Council noted further that Professor Chakraborty only submitted his aforesaid letters through e-mail which was not followed up by any hard copy with his signature thereon.



After thorough discussion on the letters submitted by Professor Falguni Chakraborty, former Professor, Department of Anthropology, complaining against the decisions of the University authority and after careful consideration of the content of such letters, the Executive Council condemned him for disobeying/declining/defying the jurisdiction of any authority of the Vidyasagar University though he still receives his monthly pension from the University. The Executive Council strongly condemned the language and arrogant nature of his expressions challenging the authority and wisdom of the Executive Council and other authorities of Vidyasagar University and also personally attacking Dr. J.K. Nandi, Registrar of Vidyasagar University. It was noted and resolved further that Dr. J.K. Nandi while discharging his official duties was not acting in his individual or personal capacity but he was signing or circulating all documents as the Registrar and the Secretary of the Executive Council as per the University Act & Statutes. Therefore, if any litigation arises in future the University will act and defend itself and its officials as per existing norms. It was resolved further the following :

- (1) Hereafter no academic or administrative work of the University will be assigned to Professor Chakraborty. If any academic or administrative work remains to be completed by Professor Chakraborty in this University, such assignments will be re-assigned by the appropriate academic and administrative bodies.
- (2) Professor Chakraborty will not be permitted to enter the University campus without prior written permission from the University authority henceforth. If he enters the campus without prior permission or knowledge of the University, he will be treated as a trespasser and necessary action will be taken against him as per the law of land.
- (3) An FIR be lodged against Professor Chakraborty for obstructing Dr. J.K. Nandi, Registrar of Vidyasagar University, to discharge his duties as a public servant without any hindrance.
- (4) A letter be sent to the Department of Higher Education, Science & Technology and Biotechnology requesting to advise for further course of action to be followed by the Vidyasagar University.
- (5) The Registrar be requested to send the decisions of the Executive Council of Vidyasagar University in this regard to the Department of Higher Education, Science & Technology & Biotechnology, Government of West Bengal, other Universities in West Bengal, West Bengal College Service Commission, the University Grants Commission, New Delhi, Anthropological Survey of India and other institutions of higher learning.
- (6) the Vidyasagar University authority will take strong and appropriate measures against Professor Chakraborty if he maligns or offend to Dr. J.K. Nandi, Registrar, and or any other personnel of Vidyasagar University.
- (7) Hereafter no other communications in this regard from Professor Chakraborty will be entertained and responded to by the University.
- (8) the aforesaid decision taken by the Executive Council in its meeting dated 06.11.2017 and this resolution has been taken as confirmed.
- (9) The Registrar be requested to communicate this decision of the Executive Council to Professor Chakraborty in this regard.

- 06(g) To place before the Executive Council of Vidyasagar University, the draft Regulations for B.A./B.Sc./B.Com (Honours & General) 3-Year Degree Course Under Choice Based Credit System (CBCS) of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed draft Regulations for B.A./B.Sc./B.Com (Honours & General) 3-Year Degree Course Under Choice Based Credit System (CBCS) of Vidyasagar University submitted by the Secretary, Council for Undergraduate Studies of this University.*

*After thorough discussion on the draft Regulations for B.A./B.Sc./B.Com (Honours & General) 3-Year Degree Course Under Choice Based Credit System (CBCS) of Vidyasagar University, it was resolved that the said Regulations for B.A./B.Sc./B.Com (Honours & General) 3-Year Degree Course Under Choice Based Credit System (CBCS) of Vidyasagar University be accepted and approved. Resolved also that the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard.*

- 06(h) To place before the Executive Council of Vidyasagar University, the note dated 03.11.2017 prepared and submitted by the Controller of Examinations (Actg.) of Vidyasagar University pertaining to selection of lowest bidder through Expression of Interest for preparation of the result oriented works of PG courses of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the note dated 03.11.2017 prepared and submitted by the Controller of Examinations (Actg.) of Vidyasagar University stating that the Expression of Interest (EOI) was invited from the bonafide resourceful service providers for preparation of the result oriented works of PG courses of this University. On the basis of the said EOI eight service providers were submitted their EOI for this purpose and out of them M/s. Mega Calibre Enterprises(P) Ltd., Kolkata has been selected as lowest bidders for this purpose.*

*After thorough discussion on the note prepared and submitted by the Controller of Examinations (Actg.) of Vidyasagar University and careful consideration of the comparative statements prepared pertaining to selection of lowest bidder through Expression of Interest for preparation of the result oriented works of PG courses of Vidyasagar University, it was resolved that M/s. Calibre Enterprises (P) Ltd., Kolkata who has been selected as lowest bidder through Expression of Interest be issued the work order for preparation of the said result oriented works. Resolved also that the Controller of Examinations of this University be requested to process further in this regard.*

- 06(i) To consider the letter dated 30.10.2017 submitted by Professor Bidhan Chandra Patra, Department of Acquaculture Management & Technology through mail seeking permission for renovation of existing pond, construction of Ornamental Fish Unit at Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 30.10.2017 submitted by Professor Bidhan Chandra Patra, Department of Acquaculture Management & Technology through mail seeking permission for renovation of existing pond, construction of Ornamental Fish Unit at Vidyasagar University.*

*After thorough discussion on the letter submitted by Professor Bidhan Chandra Patra, Department of Acquaculture Management & Technology*

through mail seeking permission for renovation of existing pond, construction of Ornamental Fish Unit at Vidyasagar University, it was resolved that further information/proposal from the D.B.T. be sought for by Professor Patra in this regard and the same be placed before the next meeting of the Executive Council for consideration.

- 06(j) To place before the Executive Council of Vidyasagar University, the letter dated 30.10.2017 submitted by Prof. Radha Raman Pal, Convener, SMCP-2018 pertaining to sanctioning of an amount of Rs.50,000/- from the UGC Unassigned Grant for smooth conduct of the 9th Vidyasagar Satyendra Nath Bose National Workshop on Science of Materials : Challenges and Prospects (SMCP-2018).

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 30.10.2017 submitted by Prof. Radha Raman Pal, Convener, SMCP-2018 along with the budget estimate stating that the Department of Physics and Techno-Physics of this University with the financial support of the Theoretical Physics Seminar Circuit of S. N. Bose National Centre for Basic Sciences, Kolkata and DST, New Delhi is going to organize 9th Vidyasagar Satyendra Nath Bose National Workshop on Science of Materials : Challenges and Prospects (SMCP-2018) proposed to be held during 17-19 January, 2018 at the Vidyasagar University Campus. There will be nearly twenty invited lectures by experts/eminant scientists and a contributory poster session by the research workers. More than 200 participants comprising nearly 150 senior postgraduate students, 60 university/college teachers and researchers and 20 invited speakers may be attended in the said workshop. The total budget for hosting the said workshop is Rs.3.6 lacs out of which they have applied for Rs.2.00 Lacs from SNBNCBS, Kolkata. In this connection he has requested to sanction an amount of Rs.50,000/- from the UGC Unassigned Grant of this University for meeting the whole expenses for the said workshop.

After thorough discussion on the letter submitted by Prof. Radha Raman Pal, Convener, SMCP-2018 pertaining to sanctioning of an amount of Rs.50,000/- from the UGC Unassigned Grant for smooth conduct of the 9th Vidyasagar Satyendra Nath Bose National Workshop on Science of Materials : Challenges and Prospects (SMCP-2018), it was resolved that out of Rupees Fifty thousand (Rs.50,000/-) only, Rupees twenty five thousand (Rs.25,000/-) only [ Rupees Fifteen thousand (Rs.15,000/-) only from the DDE Fund and Rupees ten thousand (Rs.10,000/-) only from the University fund] be sanctioned and rest of Rupees twenty five thousand (Rs.25,000/-) only be sanctioned from the UGC Unassigned Grant of this University for the said workshop.

- 06(k) To consider the letter bearing No. RMLC/VU/Adm/2017 dated 30.10.2017 submitted by the Principal of MIES R.M. Law College, Sonarpur pertaining to extension of permanent affiliation to MIES R.M. Law College for conducting 3-Yerar LL.B. Course from the academic session 2015-2016.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. RMLC/VU/Adm/2017 dated 30.10.2017 submitted by the Principal of MIES R.M. Law College, Sonarpur stating that the college has running 3-Year LL.B. Course since 2015-2016 session under the affiliation of Vidyasagar University on fulfillment of terms & conditions laid down by the University authority. A good number of students pursuing the said course in full swing. In this connection he has requested to extend permanent affiliation to them so that the college may run the course uninterruptedly for the benefits of the students. Resolved also that the Inspector of Colleges of this University be requested to process further in this regard as per the norms of the University.

- 06(l) To consider the letter bearing No. HLC/October/2017/424 dated 27.10.2017 submitted by the Principal-in-Charge of Haldia Law College pertaining to reduction of Enlistment Fees per student per semester.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. HLC/October/2017/424 dated 27.10.2017 submitted by the Principal-in-Charge of Haldia Law College stating that the University has increased the Enlistment Fees per student per semester which is an exorbitant hike compared to the previous fees that would undoubtedly escalate the cost of education. In this connection he has requested to reduce the fees per student per semester.*

*After thorough discussion on the letter submitted by the Principal-in-Charge of Haldia Law College pertaining to reduction of Enlistment Fees per student per semester, it was resolved that the said Enlistment fees of Haldia Law College be reduced to Rupees one thousand five hundred (Rs.1,500/-) per semester per year for LL.B. course and Rupees Eight hundred (Rs.800/-) only per semester per year for P.G. course. Other fees as notified earlier will remain same. Resolved also that the Inspector of Colleges of this University be requested to process further in this regard.*

- 06(m) To discuss the matter regarding engagement of an agency for conducting the written examinations in different Non-teaching posts of Vidyasagar University lying vacant and ready for recruitment.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed category-wise Non-teaching posts of Vidyasagar University are lying vacant and ready for recruitment prepared and submitted by the Establishment Section of this University. The Executive Council also noted the number of candidates are eligible and not eligible in different posts category-wise after scrutiny.*

*After thorough discussion on the matter regarding engagement of an agency for conducting the written examinations in different Non-teaching posts of Vidyasagar University lying vacant and ready for recruitment, it was resolved that an outside agency be appointed for conducting the said written examination for short listing of candidates in different posts as there are a large number of applications received by the University for different non-teaching posts. Resolved also that the selection of agency for this purpose, the matter be forwarded to the Working Committee of Vidyasagar University for necessary action.*

- 06(n) To place before the Executive Council of Vidyasagar University, the letter dated 27.10.2017 received from the Manager (Marketing) of Ruby General Hospital Ltd., Kolkata regarding offering the hospital benefits both for indoor and outdoor patients for the stakeholders of Vidyasagar University.

**Resolution:** *Consideration of the item was deferred.*

- 06(o) To place before the Executive Council of Vidyasagar University, the note dated 06.11.2017 prepared by the Officer on Special Duty (Examinations) and duly forwarded by the Controller of Exmainations (Actg.) of Vidyasagar University pertaining to changing the existing provision regarding granting of grace marks in postgraduate courses under regular mode.

**Resolution:** *The Executive Council of Vidyasagar University noted the note dated 06.11.2017 prepared by the Officer on Special Duty (Examinations) and duly forwarded by the Controller of Examinations (Actg.) of*



Vidyasagar University pertaining to changing the existing provision regarding granting of grace marks in postgraduate courses under regular mode.

After thorough discussion on the note put forwarded by the Controller of Examinations of Vidyasagar University pertaining to changing the existing provision regarding granting of grace marks in postgraduate courses under regular mode, it was resolved that said provision as proposed by the Controller of Examinations be accepted with minor modifications. The corrected provision is as follows :

"The grace marks awarded shall be added with one or two courses in the final semester in which the student secures the lowest marks or as decided by the Controller of Examinations based on the feasibility. If marks increase after Review and the increased marks exceed the grace marks, only extra marks above grace marks will be added."

- 06(p) To place before the Executive Council of Vidyasagar University, the note dated 05.11.2017 put forwarded by the Deputy Registrar and State Public Information Officer of Vidyasagar University regarding exemptions from disclosure of information in consonance with the Right To Information Act – 2005.

**Resolution:** After thorough discussion on the note put forwarded by the Deputy Registrar and State Public Information Officer of Vidyasagar University regarding exemptions from disclosure of information in consonance with the Right To Information Act – 2005, it was resolved that the following matters/documents be exempted from the disclosure of information under the RTI Act – 2005 henceforth :

- (1) Material evidences and/or witnesses, depositions, documentary proof etc. submitted and/or made before any enquiry committee.
- (2) Any documents related to Internal Complaints Committee (ICC) containing sensitive private information regarding individual's dignity or self respect.
- (3) CC TV footage of any area inside the University campus.
- (4) Audio-visual recordings of any enquiry proceedings and/or investigation process.
- (5) Matters related to information which would endanger the life and may harm the security of any individual or public servant.
- (6) Matters, disclosure of which may be harmful to maintain the absolute security and strategic interest, if any, of the nation, central/state govt.s, public or private organizations and/or Vidyasagar University.
- (7) Resolutions/findings of any enquiry proceedings.
- (8) Information which may hamper the process of any investigation and/or enquiry.
- (9) Name and particulars of the Experts of any selection process.
- (10) The answer scripts of entrance or competitive examinations conducted by the University.
- (11) Any other information which may be considered as not to be disclosed and/or exemptions from disclosure of information as per the University policy from time to time.

Resolved also that the aforesaid documents/materials marked classified will not be released as per provision of RTI Act. However, such documents will be provided on demand to authorized national/international/internal investigating agencies and to Hon'ble Courts of Law.



**Renewal of contract :** 07(a) To consider the letter bearing No. VU/CL/ADM/262/17 dated 22.09.2017 submitted by Shri Debayan Nanda, Technical Assistant (IT) (Contractual), Office of the Central Library of this University pertaining to renewal of his contract service for a further period.

Resolved that the contract period of Shri Nanda in the post of Technical Assistant (IT) of this University be renewed for a further period of two years with effect from 08.10.2017 or until further order whichever is earlier based on the Performance Appraisal Report during his last contract period submitted by the concerned Head of the department with admissible allowances as per the norms of the University.

07(b) To consider the application bearing dated 31.10.2017 submitted by Shri Uttam Kumar Saha, Technical Assistant (Contractual), Department of Electronics of this University pertaining to renewal of his contract service for a further period.

**Resolution :** The Executive Council of Vidyasagar University considered the letter dated 31.10.2017 submitted by Shri Uttam Kumar Saha, Technical Assistant in the Department of Electronics of this University purely on contract basis pertaining to renewal of his contract service in his present post for a further period.


