

In this connection, the Officer-in-Charge has requested to enhance 10% seats of such courses in addition to the existing one from the academic session 2017-2018.

After thorough discussion on the letter submitted by the Officer-in-Charge, Salboni Government College, Bhimpur pertaining to enhancement of seats in different honours subjects from the academic session 2017-2018, it was resolved that two (02) seats in each of Bengali, History and Sanskrit honours course of Salboni Government College be enhanced in addition to the existing intake capacity from the academic session 2017-2018 and the Inspector of Colleges be requested to communicate the same to the concerned college in this regard.

- 06(n) To place before the Executive Council of Vidyasagar University, the enquiry report submitted by the Enquiry Committee constituted regarding issuing of Paper - VIII question papers in Mathematics instead of Paper - VII question papers in the B.Sc. Part-III Examinations, 2017 at the Ghatal Rabindra Satabarshiki Mahavidyalaya Centre held on 06.04.2017.

**Resolution:** The Executive Council of Vidyasagar University noted that on the basis of news published in the newspaper for leakage of question papers, the Hon'ble Vice-Chancellor of this University constituted an Enquiry Committee to enquire the whole matter regarding issuing of Paper - VIII question papers in Mathematics instead of Paper - VII question papers in the B.Sc. Part-III Examinations, 2017 at the Ghatal Rabindra Satabarshiki Mahavidyalaya Centre held on 06.04.2017 and to submit a report in this regard. The Executive Council also noted the detailed report submitted by the enquiry committee in this regard.



After thorough discussion on the enquiry report submitted by the duly constituted enquiry committee regarding issuing of Paper - VIII question papers in Mathematics instead of Paper - VII question papers in the B.Sc. Part-III Examinations, 2017 at the Ghatal Rabindra Satabarshiki Mahavidyalaya Centre held on 06.04.2017, it was resolved that a copy of the said report be sent to the Principal/Teacher-in-Charge of Ghatal Rabindra Satabarshiki Mahavidyalaya for placing before the Governing Body of the said college for necessary action. Resolved also that the Principal/Teacher-in-Charge be also requested to intimate to the University the course of action taken by the Governing Body of the college based on the said report of the enquiry committee. Resolved further that a letter of censure be issued to the Principal/Teacher-in-Charge of the said college not to repeat such practice in future.

- 06(o) To consider the letter dated 14.03.2017 submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University pertaining to his placement to the next higher pay band under the Career Advancement Scheme after completion of ten years of continuous and satisfactory service in the post of Secretary to the Vice-Chancellor with effect from 01.12.2009.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 14.03.2017 submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University pertaining to his placement to the next higher pay band under the Career Advancement Scheme after completion of ten years of continuous and satisfactory service in the post of Secretary to the Vice-Chancellor with effect from 01.12.2009. The Executive Council also noted the note dated 02.05.2017 prepared and submitted by the Audit Officer of Vidyasagar University regarding the placement of Shri Paul in the next higher pay band in this regard.

After thorough discussion on the letter submitted by Shri Koushik Paul, Secretary to the Vice-Chancellor of Vidyasagar University pertaining to his placement to the next higher pay band under the Career Advancement Scheme after completion of ten years of continuous and satisfactory service in the post of Secretary to the Vice-Chancellor with effect from 01.12.2009 and careful consideration of the note prepared and submitted by the Audit Officer in this regard, it was resolved that Shri Paul be placed in the next higher pay band of Rs.15,600-39,100/- with Grade Pay of Rs.6,000/- with retention of same designation under the Career Advancement Scheme with effect from 01.12.2009 in terms of G.O. bearing No. 1083(8)-Edn(U) dated 18.08.1990 of the Higher Education Department, Government of West Bengal provided that he will not be eligible to any further advancement under this scheme.

- 06(p) To place before the Executive Council of Vidyasagar University, the letter bearing D.O. No. 1-15/2009(ARC)Pt.III dated 17.03.2017 received from the Secretary, University Grants Commission, New Delhi pertaining to showing four short films and a documentary film to counsel students on ill effects of ragging developed by the University Grants Commission regularly during orientation and other programmes.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing D.O. No. 1-15/2009(ARC)Pt.III dated 17.03.2017 received from the Secretary, University Grants Commission, New Delhi stating that in pursuance to the Judgement of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on

*Curbing the Menace of Ragging in Higher Educational Institutions, 2009". Ragging is a criminal offence and the UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. These regulations are mandatory. Any violation of UGC regulations or if any institution fails to take adequate steps to prevent ragging or does not act in accordance with these regulations or fails to punish perpetrators of incidents of ragging suitably will attract action under the UGC Act. The UGC has got developed four short films and a documentary film to counsel students on ill effects of ragging. In this connection, the Secretary has requested to show these films regularly to the students during orientation and other programmes.*

*After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to showing four short films and a documentary film to counsel students on ill effects of ragging developed by the University Grants Commission regularly during orientation and other programmes, it was resolved that the Programme Co-ordinator of N.S.S., Vidyasagar University be requested to look into the matter. Resolved also that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of this University be requested to look into the matter in respect of all affiliated colleges and the Programme Co-ordinator, NSS, the Dean of Students' Welfare and the Secretary, Faculty Councils for Postgraduate Studies be requested to look into the matter in the University campus. Resolved further that the Inspector of Colleges of this University be requested to communicate the same to the undergraduate colleges affiliated to Vidyasagar University.*

- 06(q) To place before the Executive Council of Vidyasagar University, the proposal submitted by the Director of Computer Centre of this University pertaining to extension of Smart Campus Components like, signature verification for office of the Controller of Examinations, leave management system, extra four numbers of EIAT terminal etc. for modernisation of Vidyasagar University Campus into Smart Campus.

Resolution: *The Executive Council of Vidyasagar University noted the proposal submitted by the Director of Computer Centre of this University stating that as per the direction of the Hon'ble Vice-Chancellor and subsequently the decision taken by the ICT Working Committee they requested M/s. CDAC to submit the extension of the smart campus components like Signature Verification for Office of the Controller of Examinations, Leave Management System and Extra four nos. of EIAT terminal required for existing smart campus project.*

*After thorough discussion on the proposal submitted by the Director of Computer Centre of this University pertaining to extension of Smart Campus Components like, signature verification for office of the Controller of Examinations, leave management system, extra four numbers of EIAT terminal etc. for modernisation of Vidyasagar University Campus into Smart Campus, it was resolved that the said proposal of the Director of Computer Centre be accepted in principle. Resolved also that the matter be referred to the Finance Committee of Vidyasagar University for necessary action.*



- 06(r) To place before the Executive Council of Vidyasagar University, the matter regarding the promotion of Dr., Keshab Chandra Mondal, Associate Professor, Department of Microbiology of Vidyasagar University to the post of Professor under CAS.

Resolution: After thorough discussion on the matter regarding the promotion of Dr., Keshab Chandra Mondal, Associate Professor, Department of Microbiology of Vidyasagar University to the post of Professor under CAS, it was resolved that the matter be deferred till the next meeting in view of the pending UGC guideline regarding Journal & CAS.

- 06(s) To place before the Executive Council of Vidyasagar University, the reply letter dated 10.03.2017 submitted by Shri Sudarshan Singh, Junior Assistant-cum-Typist, Office of the Controller of Examinations regarding his negligence of duty at Vidyasagar University.




