Resolved also that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of Vidyasagar University be requested to process further as per the norms of the University.*

- 08(p) To place before the Executive Council of Vidyasagar University, the letter bearing No. JS-Affi(VU)/148/SCHE/2016 dated 20.06.2016 received from the Joint Secretary, West Bengal State Council of Higher Education pertaining to extension of affiliation of PG courses in Garhbeta College with effect from the academic session 2016-2017.



**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. JS-Affi(VU)/148/SCHE/2016 dated 20.06.2016 received from the Joint Secretary, West Bengal State Council of Higher Education stating that the Expert Committee constituted by the Council for introduction of PG courses in Physics, Chemistry, Mathematics in Garhbeta College inspected the respective departments of the college on 22/05/2016 and recommended for affiliation of the said courses from the academic session 2016-2017. In this connection he has placed the matter to the University authority for consideration. The Executive Council also noted the Inspection Reports along with the recommendations submitted by the Expert Committee constituted by the Council for this purpose.*

*After thorough discussion on the letter received from the Joint Secretary, West Bengal State Council of Higher Education and careful consideration of the recommendation of the Expert Committee constituted by the State Council of Higher Education for this purpose, it was resolved that the Inspection Reports along with the recommendations of the Expert Committee submitted by the Council be accepted and the Inspector of Colleges and the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to take further process in this regard as per the norms of the University.*

- 08(q) To consider the letter dated 14.06.2016 submitted by Ms. Bandana Sahoo, Jr. EPABX Operator of Vidyasagar University pertaining to extension of Earned Leave during the period from 14.06.2016 to 12.08.2016 for her rest during high-risk pregnancy stage.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 14.06.2016 submitted by Ms. Bandana Sahoo, Jr. EPABX Operator of Vidyasagar University stating that she is unable to join her duty at this University now as she is carrying a high-risk pregnancy with so many complications. Her doctor advised her to take rest from 14.06.2016 to 12.08.2016 for this purpose. In this connection, she has requested to extend her Earned Leave during the period as stated above advised by her doctor. The Executive Council also noted the medical supporting documents submitted by Ms. Sahoo in this respect.*

*After thorough discussion on the letter submitted by Ms. Bandana Sahoo, Jr. EPABX Operator of Vidyasagar University pertaining to extension of Earned Leave during the period from 14.06.2016 to 12.08.2016 for her rest during pregnancy stage and careful consideration of the supporting medical documents, it was resolved that the Earned Leave during the period as stated herein above be extended to her as per the norms of the University for this purpose.*

- 08(r) To place before the Executive Council of Vidyasagar University, the letter dated 03.06.2016 submitted by the Head, Department of History, Vidyasagar University pertaining to permission for hosting the 51<sup>st</sup> Annual Conference of the Institute of Historical Studies at the Vidyasagar University on 1<sup>st</sup> week of October, 2016.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 03.06.2016 submitted by the Head, Department of History, Vidyasagar University stating that the Departmental Committee of History of the Vidyasagar University in its meeting dated 17.05.2016 has agreed to host the 51<sup>st</sup> Annual Conference of the Institute of Historical Studies at our University on 1<sup>st</sup> week of October, 2016. The Executive Council has also*



noted the tentative budget prepared and submitted by the Head along with the said letter for hosting the said conference in this University.

After careful consideration of the letter submitted by the Head, Department of History, Vidyasagar University pertaining to permission for hosting the 51<sup>st</sup> Annual Conference of the Institute of Historical Studies at the Vidyasagar University on 1<sup>st</sup> week of October, 2016, it was resolved that the Department of History of this University be permitted to host the said conference at this University. Resolved also that the financial assistance up to a maximum ceiling of Rs.50,000/- (Rupees fifty thousand) only, if required for this purpose, be released from the University for this purpose.

- 08(s) To place before the Executive Council of Vidyasagar University, the Note dated 20.06.2016 prepared by the office of the Registrar pertaining to conversion of some reserved teaching and non-teaching posts of Vidyasagar University to general category.

**Resolution:** Consideration of the item was deferred.

- 08(t) To place before the Executive Council of Vidyasagar University, the Inspection Reports submitted by the duly constituted Inspection Teams pertaining to extension of temporary affiliation to four self-financing B.Ed. Colleges for conducting 2-Year B.Ed. course from the academic session 2016-2017.

**Resolution:** The Executive Council of Vidyasagar University considered the Inspection Reports submitted by the Inspection Teams constituted for the purpose of temporary affiliation to (a) Vidyasagar Primary Teachers' Training Institute, (b) Swami Vivekananda Tribal College of Teachers' Education, (c) Moyna Vivekananda Mission Teachers' Training College and (d) Usharani College of Education for conducting 2-Year B.Ed. course from the academic session 2016-2017.

After thorough discussion on the Inspection Reports submitted by the duly constituted Inspection Teams pertaining to extension of temporary affiliation to four self-financing B.Ed. Colleges for conducting 2-Year B.Ed. course from the academic session 2016-2017, it was resolved that temporary affiliation be extended to (a) Vidyasagar Primary Teachers' Training Institute, (b) Swami Vivekananda Tribal College of Teachers' Education, (c) Moyna Vivekananda Mission Teachers' Training College and (d) Usharani College of Education for conducting 2-Year B.Ed. course from the academic session 2016-2017 subject to fulfillment of the terms & conditions recommended by the teams in their respective reports. Resolved also that the Inspector of Colleges of Vidyasagar University be requested to process further.

- 08(u) To place before the Executive Council of Vidyasagar University, the Judgement bearing W.P. No. 10082(W) of 2016 passed by Hon'ble Justice Debangshu Basak of Calcutta High Court on 20.06.2016 pertaining to introduction of B.A./B.Sc. B.Ed. (Integrated 4-Year duration) Course from the academic session 2016-2017 at the Kadambini Women's College of Education.

**Resolution:** The Eighth Executive Council of the Vidyasagar University noted the detailed judgement passed by the Hon'ble Justice Debangshu Basak of Calcutta High Court on 20.06.2016 pertaining to introduction of B.A./B.Sc. B.Ed. (4-Year Integrated) Course from the academic session 2016-2017 at the Kadambini Women's College of Education bearing W.P. No.



10082 (W) of 2016 filed by the authority of Kadambini Women's College of Education against the State of West Bengal & Others. The Eighth Executive Council also noted that in the said judgement, His Lordship directed to consider the case of the petitioner by the Executive Council of Vidyasagar University in its first meeting scheduled to be held on 23<sup>rd</sup> June, 2016 and the petitioners will be given a reasonable opportunity of hearing by the Executive Council. His Lordship gave the liberty to the petitioner to be represented by an Advocate before the Executive Council. Accordingly notice was sent to the Kadambini Women's College informing the time of hearing.

On the basis of the said judgment passed by the Hon'ble High Court of Calcutta, Mr. Atarup Banerjee, Advocate on behalf of the petitioner (Kadambini Women's College of Education) appeared before the Executive Council in its first meeting held on 23.06.2016 in the University campus for hearing and presented the case in the said meeting. The house unanimously disapproved the indecent language and aggressive tone used by the advocate who represented the petitioner and who expressed aspersion on the integrity of the lady Advocate who presented the case at the Calcutta High Court on behalf of the Vidyasagar University and also the Registrar of Vidyasagar University, the official signatory on behalf of the University as per the Act, Statute & Ordinances of the Vidyasagar University, thereby maligning the Vidyasagar University Authority, especially the Executive Council (EC), the highest executive body of the University.

The EC noted that the Ld. Advocate quoted the example of other colleges where there was only single course but the VU authority extended the affiliation to those colleges earlier to offer M.P.Ed and M.Ed. The EC further noted the statement of Ld. Advocate who mentioned that as the NOC was issued earlier by the VU authority to Kadambini Women's College, and the VU has collected Rs. Thirty thousand (Rs. 30000/-) only as inspection fee, the VU authority now should give affiliation to the college to offer this B.A./B.Sc. B.Ed (4-Year Integrated) course.

After hearing to Ld. Advocate for Kadambini Women's College of Education Atarup Banerjee, and after considering the Relevant Act, Regulations of NCTE, Relevant Act, Regulations of UGC, V.U. Act, Statute & Ordinances as also the Involvement of State Government through the Higher Education Department and the relevant facts of the case, the E.C. came to the following findings leading to final decision:

- a) NCTE by NCTE (Recognition Norms and Procedures) Regulations, 2014 published on 28.11.2014, for the first time introduced the 4 years' B.A./B.Sc B.Ed integrated Course as also amended B.Ed. course from 1 Year to 2 Years.
- b) Colleges are required to take fresh recognition from NCTE for this Course;
- c) NCTE Regulations, 2014 speaks about taking NOC from Affiliating University prior to making application for recognition to NCTE;
- d) NOC from Concerned State Government is also required;
- e) Kadambini College applied on 01/06/2015 before The University for the purpose of making application for recognition to NCTE for this new 4 years' B.A./B.Sc B.Ed integrated Course;



- f) The University granted 'No Objection' for Recognition from NCTE, though inadvertently, it was mentioned 'No objection for Affiliation';
- g) In any event, according to NCTE Regulations, 2014, "No Objection" was required from Concerned State Government/Affiliating University for the purpose of Recognition .As per Section 14(6)of NCTE ACT, no step for Affiliation including No Objection can be initiated prior to Recognition from NCTE;
- h) Participation in selection process for selection of Faculty members was also undertaken by the University as this is also a pre-condition for Recognition from NCTE and the List of Faculty members is required enclosure of the application of college for recognition;
- i) Kadambini College received recognition from NCTE on 03/3/2016 and applied for affiliation from the University;
- j) As Affiliation is not automatic upon Recognition and it requires fulfilment of Statutory Provisions of University including Inspection in this regard, Kadambini College deposited fees of Rs. 30,000/- with the University towards Inspection fees;
- k) But, The University did not undertake inspection for the following reasons:
  - i) B.A./B.Sc B.Ed integrated Course is a combination of both Regular course of B.A./B.Sc controlled & regulated by UGC as also a Professional Course of B.Ed controlled & regulated by NCTE;
  - ii) As per Sub-section (3) of Section 22 of UGC Act, UGC is the Authority to specify the Degrees both under-graduate & post-graduate level with the approval of Central Government;
  - iii) As per Sub-section (2) of Section 12 of UGC Act, UGC is the Authority to specify the nature of any 'Course of Study' for obtaining any qualification from any University.
  - iv) UGC, in exercise of power conferred by Sub-section (2) of Section 12 specifies a particular course of Study, but it appears from the Notification issued on 21<sup>st</sup> July,2015 that this Integrated course and its 'Course of Study' has not been specified as yet; only B. Ed Course and degree has been amended to 2 years. The University did not find any other specification/notification as required;
  - v) According to UGC (Affiliation of Colleges by Universities) Regulations, 2009, affiliation may be granted to the colleges for a 'Course' which comprises a 'Programme of study' which means a 'Higher Education Programme' persuaded for a degree specified by the Commission U/S 22(3) of the UGC Act;
  - vi) M.P.Ed. and M.Ed. Course as notified by the University Grants Commission (UGC).
  - vii) As per UGC (Affiliation of Colleges by Universities) Regulation, 2009 amended from time to time, eligibility criteria was provided for affiliation in respect of a 'Course of Study' persuaded for a degree as specified by the Commission ;
  - viii) In the circumstances, University sought for permission on from UGC which is yet to come ;
- l) As per NCTE & UGC Acts and Regulations, State Government in its Higher Education Department has a vital role to play;



- m) State Government has yet to take any steps for starting this integrated course and its admission process for the State aided Universities;
- n) University sought for information from State Government which is yet to come;
- o) Furthermore, at present, there are 25 more affiliated un-aided private B.Ed Colleges & 6 Government Aided B.Ed Colleges and affiliation of 23 other Colleges are under process;
- p) Out of those 25 affiliated un-aided private B.Ed Colleges, only six (06) Colleges applied for 'No Objection' for making application for Recognition for this new Integrated Course only in March & April, 2016 which could not be processed due to no Notification from UGC recognising/ specifying this Course and degree as also for permission from State Government.

**DECISION:**

For all this reasons, it is resolved that the University cannot start a New 'Course Of Study' [B.A./B.Sc. B.Ed.(4-Year Integrated)] and/or award New Degree involving non-traditional Regular course without having Approval/Notification from UGC and/or State Government as the University has so far extended affiliation of regular B.A/B.Sc. Courses to Govt. or Govt.-aided colleges only and no B.A./B.Sc. B.Ed.(4-Year Integrated) course is run at present by any of its affiliated colleges.

It is Further resolved that pending such Approval/Notification from UGC and/or State Government, Process for affiliation cannot be started in 2016-2017 upon the application for affiliation made by Kadambini Women's College and the money deposited by the College towards inspection be refunded to the said College.
