**Resolution:** The Executive Council of Vidyasagar University noted the Judgement passed by the Hon'ble Justice Debangshu Basak of High Court, Calcutta on 08.01.2016 against the Writ Petition bearing W.P. No. 22137(W) of 2015 filed by Shri Soumen Pal, former Junior Peon of this University regarding his termination from the Vidyasagar University stating that "he find no infirmity in the action taken by the University authority. In so far as the language in the letter of termination is concerned, he is of the view that the same is not stigmatic. The performance of the writ petitioner was considered during the extended period of his probation. Such performance found unsatisfactory. The unsatisfactory performance is stated in the letter of termination as the reason for termination. In such circumstances, there is no merit in the writ petition and the same is dismissed".

After thorough discussion on the Judgement passed by the Hon'ble Justice Debangshu Basak of High Court, Calcutta against the Writ Petition W.P. No. 22137(W) of 2015 filed by Shri Soumen Pal, former Junior Peon of this University challenging the decision of the University authority regarding discharging his duties as Junior Peon from Vidyasagar University, it was resolved that the post of Junior Peon be declared as vacant and necessary steps for filling-up the said post in this University be taken up immediately as per the norms of the University.



- 05.(c) To note the Judgement passed by the Hon'ble Justice Debangshu Basak of High Court, Calcutta on 25/01/2016 against the Writ Petition bearing W.P. No. 759(W) of 2016 filed by Dr. Abhijit Guha, Professor, Department of Anthropology of this University.

**Resolution :** *The Executive Council of Vidyasagar University noted the detailed Judgement passed by the Hon'ble Justice Debangshu Basak of High Court, Calcutta on 25.01.2016 against the Writ Petition bearing W.P. No. 759(W) of 2016 filed by Dr. Abhijit Guha, Professor, Department of Anthropology of this University challenging the charge sheet issued by the Vidyasagar University. The Executive Council noted also the reply dated 08.02.2016 on the Charge-sheet dated 28/12/2015 submitted by Professor Abhijit Guha, Department of Anthropology of this University. The Executive Council noted further the letters dated 01/02/2016 & 15/02/2016 respectively submitted by Professor Guha to the Hon'ble Vice-Chancellor of Vidyasagar University regarding his charge sheet and other related matters. The Executive Council noted again that the Enquiry Committee consisting of two Enquiry Officers and the Presenting Officer based on the said charge sheet has been constituted as per the decision of the Executive Council taken in its earlier meeting dated 25/01/2016 and also the verdict of the Hon'ble High Court, Calcutta.*

*After thorough discussion on the letter dated 15.02.2016 submitted by Professor Guha regarding his charge sheet and other related matters, the Executive Council of Vidyasagar University appreciated both the spirit and content of the said letter and resolved that a letter be sent to Professor Guha seeking his opinion immediately whether the above mentioned letter of Prof. Guha supersedes his reply dated 08/02/2015 to the Charge Sheet dated 28/12/2015 issued to him and whether the same still holds ground notwithstanding his communication to the Hon'ble Vice-Chancellor. Professor Guha also should indicate the fate of the court cases against the Vidyasagar University administration initiated by him. Resolved further that after receiving the opinion from Professor Guha in this regard, the matter be placed again before the Executive Council for final decision in this regard.*

- 06(i) To consider the letter dated 04/02/2016 submitted by the Secretary, Haldia Law College, Haldia pertaining to withdrawal of the restriction of Age Limit from the Law courses under Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 04/02/2016 submitted by the Secretary, Haldia Law College, Haldia along with the judgement passed by the Hon'ble High Court on 01/02/2016 on the writ bearing W.P. No. 16453(W) of 2015 with CAN 855 of 2016, filed by Sk. Mafidul Islam stating that His Lordship on the said writ passed an order stating that the age restriction imposed by the Board of Studies of the Vidyasagar University is based upon the age restriction imposed by the Bar Council of India and as the Bar Council of India has withdrawn such age restriction pursuant to the judgement of the Hon'ble Supreme Court of India, the basis for the age restriction imposed by the Board of Studies of the Vidyasagar University does not remain. In such circumstances, the decision of the Vidyasagar University impugned herein to the extent of imposition of age restriction of admission in a law course is set aside and also directed that the writ petitioner is to be treated by the University and all concerned to have been admittedly duly on the date of the admission of such student to the law course without any age restriction. the University and other authorities will treat the writ petitioner as such. It is expected that the University authorities issues necessary documents to the writ petitioner so that the writ petitioner will participate in the ensuing examination without insisting on any age restriction and in accordance with law. In this connection, the Secretary of Haldia Law College has requested to withdraw the restrictions of age from the law courses that are run by the Vidyasagar University.

After thorough discussion on the letter dated 04/02/2016 submitted by the Secretary, Haldia Law College, Haldia pertaining to withdrawal of the



restriction of Age Limit from the Law courses under Vidyasagar University and careful consideration of the judgement passed by the Hon'ble High Court on 01/02/2016 on the writ bearing W.P. No. 16453(W) of 2015 with CAN 855 of 2016, filed by Sk. Mafidul Islam in this regard, it was resolved that the clarifications in this regard be sought for from the Bar Council of India, New Delhi. Resolved also that the Registrar and the Inspector of Colleges of this University be requested to take necessary steps in this regard.

- 06(j) To place before the Executive Council of Vidyasagar University, the report along with the recommendation of the Enquiry Committee constituted regarding the retirement benefit of the staff of DDE, who have already retired from his service and who are going to retire from their services at DDE.

After thorough discussion on the report along with the recommendation of the Enquiry Committee constituted regarding the retirement benefit of the staff of DDE, who have already retired from his service and who are going to retire from their services at DDE, it was resolved that the said enquiry report be accepted. Resolved also that all employees of the Directorate of Distance Education (DDE) of this University except contractual and other seven numbers of employees, whose names are listed in the resolution of the 7<sup>th</sup> meeting of the Advisory Committee dated 12.03.1996 and subsequently approved by the Higher Education Department, Government of West Bengal without any financial liability in its letter dated 10<sup>th</sup> March, 2000 bearing No. 320-Edn(U)/1U(Vid)-15/99, be allowed to continue in their respective posts with the following terms and conditions or clauses with effect from 01/03/2016.

- i) The concerned employee's Basic pay and other allowances would freeze (except incentive) and hereafter no increments would be allowed and will be given consolidated fixed pay based on current salary.
  - ii) They will be considered as temporary / or quasi-permanent / or unconfirmed employees of the University.

  - v) Status-quo be maintained regarding the family pensions already granted and the pension amount will be frozen and no additional allowances would be permissible in future.
- The Group C & D employees will be entitled, on satisfactory performance, to an annual allowance of Rs. 300.00 & Rs. 200.00 respectively w.e.f. 1<sup>st</sup> July, 2016.
