*After thorough discussion on the Circular issued by the Additional Secretary to the Government of West Bengal, Higher Education Department, CS Branch pertaining to implementation of the West Bengal State Higher Educational Institutions (Reservation in Admission), Act, 2013 and the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2014, it was resolved that the said Acts 2013 & 2014 respectively be implemented in Vidyasagar University for the academic session 2015-2016 for admission purposes.*

No. 1989(W) of 2015 filed by Shri Ashoke Kumar Pakhira, former employee of Vidyasagar University pertaining to release of his retiral dues stating that the petitioner is directed not to enter the University campus except for the purpose of pursuing the matter relating to release and receipt of retiral*

dues and he is entitled to interest, he shall be at liberty to submit a representation before the Vice-Chancellor who shall proceed to decide the same in accordance with law.

After thorough discussion on the Judgement passed by the Hon'ble Justice Dipankar Dutta of Single Bench of High Court, Calcutta on 06.05.2015 based on the Writ Petition bearing W.P. No. 1989(W) of 2015 filed by Shri Ashoke Kumar Pakhira, former employee of Vidyasagar University pertaining to release of his retiral dues, it was resolved that while the University is proceeding to take appropriate action regarding the directions of the Hon'ble High Court in the matter, a notification regarding entering into the University campus of Shri Pakhira as per the direction of the Hon'ble Court be issued in this regard. Resolved also that a copy of the said notification be sent to the local police station in this regard.

The Executive Council noted further the action of the Hon'ble Vice-Chancellor in directing for re-advertisement to the post of Inspector of Colleges as there was not sufficient applicants for the said post.*

West Bengal has been pleased to direct the relaxations/facilities of (a) reduction in payment of Examination fees and Application fees, (b) relaxation of marks, (c) relaxation in the duration of Examinations and (d) relaxation of Upper Age limit etc. be given to the Persons with Disabilities in every State-aided Higher Educational Institutions strictly in terms of the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.

After thorough discussion on the Notification issued by the Additional Secretary to the Government of West Bengal, Higher Education Department, University Branch pertaining to relaxations/facilities to be given to the Persons with Disabilities in every State-aided Higher Educational Institutions, it was resolved that further process in this regard be taken by the University.


- 06(d) To consider the letter dated 17.06.2015 submitted by the Teacher-in-Charge, Department of Business Administration of Vidyasagar University pertaining to list of Reviewers along with the proposed honorarium for up-gradation of Self-Learning Materials (SLMs) of MBA (DL) for getting DEB approval.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 17.06.2015 submitted by the Teacher-in-Charge, Department of Business Administration of this University along with the list of Reviewers with proposed honorarium for up-gradation of Self-Learning Materials (SLMs) of MBA(DL) stating that the Department of Business Administration has taken initiative to develop an upgraded SLM of MBA(DL) for the purpose of DEB approval. They have already distributed the responsibilities for developing the SLM to the different institutes in Kolkata those having interest for the same and they will hand over the soft copy of the SLM latest by 18th June, 2015. The SLM must be reviewed by the subject experts for maintaining the standard so that the department can easily get approval from DEB from the current session. In connection with the above he has submitted the list of Reviewers along with the proposed honorarium for this purpose for necessary approval. The Executive Council also noted the list of Reviewers along with the proposed honorarium for this purpose.*

*After thorough discussion on the letter submitted by the Teacher-in-Charge, Department of Business Administration and careful consideration of the list of Reviewers along with the proposed honorarium for up-gradation of Self-Learning Materials (SLMs) of MBA (DL) for getting DEB approval, it was resolved that the said list of Reviewers recommended by the Teacher-in-Charge, Department of Business Administration be approved for this purpose. It was resolved also that a maximum sum of Rs.3,00,000/- (Rupees three lacs) only as honorarium of the Reviewers including the printing of such materials be approved.*

- 06(e) To place before the Executive Council of Vidyasagar University, the letter dated 11.06.2015 submitted by Prof. Durga Sankar Rath, Department of Library and Information Science of this University pertaining to implement the order issued by the Higher Education Department, Govt. of West Bengal regarding the service conditions and other matters related to Librarians/Assistant Librarians/Deputy Librarians of Government-aided Colleges affiliated to Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 11.06.2015 submitted by Prof. Durga Sankar Rath, Department*



*of Library and Information Science of this University stating that as the Higher Education Department did not receive any letter from Vidyasagar University in this regard, Librarians of Colleges affiliated to Vidyasagar University have been suffering severely especially for retirement benefits, research and promotional issues and some other service condition related matters. The Executive Council also noted the respective G.O. submitted by Prof. Rath in this regard. The Executive Council noted further that the University of Calcutta has already implemented the said order. In this connection he has requested to take necessary measures in this regard and to provide such benefits to the Librarians of the Colleges affiliated to this University.*

*After thorough discussion on the letter submitted by Prof. Durga Sankar Rath, Department of Library and Information Science of this University pertaining to implement the order issued by the Higher Education Department, Govt. of West Bengal regarding the service conditions and other matters related to Librarians/Assistant Librarians/Deputy Librarians of Government-aided Colleges affiliated to Vidyasagar University, it was resolved that the implementation of the said order of the Higher Education Department, Government of West Bengal in Vidyasagar University be accepted in principle. Resolved also that the matter be incorporated in the revised Statute of Vidyasagar University.*

- 06(f) To place before the Executive Council of Vidyasagar University, the letter dated 25.06.2015 received from the Secretary, Deshapran Smriti Raksha Samity, Kolkata pertaining to installation of Full Size Statue of Deshapran Birendra Nath Sasmal in the University campus.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 25.06.2015 received from the Secretary, Deshapran Smriti Raksha Samity, Kolkata requesting for permission to the University authority for installation of a Full Size Statue of Deshapran Birendra Nath Sasmal at a prime location in the University campus. The Executive Council also noted that the cost of the said Statue will be borne by the Deshapran Smriti Raksha Samity.*

*After thorough discussion on the letter submitted by the Secretary, Deshapran Smriti Raksha Samity, Kolkata pertaining to installation of Full Size Statue of Deshapran Birendra Nath Sasmal in the University campus from their own cost, it was resolved that the proposal for installation of the said Statue in the University campus be approved. Resoled also that the matter be forwarded to the Space, Planning and Development Committee for identification of proper space in the University campus for such installation.*

- 06(g) To place before the Executive Council of Vidyasagar University, the letter dated 22.06.2015 received from Prof. Abhijit Guha, Department of Anthropology of this University regarding his unwillingness as the University Nominee to the Managing Committee of Ratulia Secondary Teachers' Training Institute, a self-financed B.Ed. College affiliated to Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted that the Executive Council of Vidyasagar University nominated Dr. Abhijit Guha, Professor, Department of Anthropology as University Nominee to the Managing Committee of Ratulia Secondary Teachers' Training Institute earlier. Accordingly the Inspector of Colleges informed such nomination to*

Prof. Guha. The Executive Council also noted that on the basis of this, Professor Guha has submitted the above mentioned letter stating his unwillingness for the said nomination.

After thorough discussion on the letter submitted by Prof. Abhijit Guha, Department of Anthropology regarding his unwillingness as the University Nominee to the Managing Committee of Ratulia Secondary Teachers' Training Institute, a self-financed B.Ed. College affiliated to Vidyasagar University, it was resolved that to take up such assignment when nominated by the higher authority or body of the Institution is a formal responsibility of faculty members of the Institution, and as such Professor Guha be requested to continue discharging the responsibility as the University Nominee to the Managing Committee of the Ratulia Secondary Teachers' Training Institute as already assigned to him.

- 06(h) To consider the letter dated 25.06.2015 submitted by Shri Abhisek Chowdhury, a pass out student in the Department of Computer Science of Vidyasagar University in the year 2015, pertaining to issuance of Rank Certificate.

**Resolution:** The Executive Council of Vidyasagar University noted the letter submitted by Shri Abhisek Chowdhury, a pass out student in the Department of Computer Science of this University stating that he has passed M.Sc. in Computer Science from this University in the year 2015 securing 82.7% of marks. The Executive Council also noted that unfortunately he got supplementary in his 2<sup>nd</sup> Semester Examinations held in the year 2014 and again appeared in the said examination in the year 2015 and secured 236 out of 300 marks. The Executive Council noted further that he got the highest marks in all four semesters examinations. In connection with the above, he has requested to issue him the Rank Certificate as per the norms of the University. The Executive Council noted again the observations made by the Controller of Examinations regarding non-eligibility of the Rank Certificate of Shri Chowdhury in this regard.

After thorough discussion on the letter submitted by Shri Abhisek Chowdhury, a pass out student in the Department of Computer Science of Vidyasagar University in the year 2015, pertaining to issuance of Rank Certificate and careful consideration of the observations made by the Controller of Examinations in this regard, it was resolved that the Rank Certificate be issued in favour of Shri Chowdhury although Shri Chowdhury got a supplementary examination to be cleared, it is on record that he did the entire course without any year lag. Resolved also that the similar system be followed in future for such case in any subject.

- 06(i) To discuss the matter regarding amendment in provision 159 of PART-VII (Discipline & Conduct) of the Vidyasagar University First Ordinances, 1985 (amended up to 1997).

**Resolution:** After thorough discussion on the matter regarding amendment in provision 159 of Part-VII (Discipline & Conduct) of the Vidyasagar University First Ordinances, 1985 (amended up to 1997), it was resolved that a Committee consisting of (a) Professor Radharaman Chakraborty, former Hon'ble Vice-Chancellor of Netaji Subhas Open University and the Member of EC, (b) Professor T.D. 


