Ten book stacks have already been arranged in that room. Now they need more stacks for new books. The Executive Council also noted that they purchased the book stacks from M/s. Nexus Furniture about 3 months ago. In this connection a repeat order may be placed to M/s. Nexus Furniture on the basis of that rate. The Executive Council noted further that the total cost involvement for 12 such book stacks is Rs.1,87,272/- (including all taxes). This amount will be spent from the Infrastructural Fund under the last year's State Book Grant.
