The Executive Council of Vidyasagar University noted the letter bearing No. 307-Edn(CS)/4C-65/2011 dated 15.03.2013 received from the Joint Secretary to the Government of West Bengal, Higher Education Department, Sponsored College Branch stating that on the recommendation of the West Bengal State Council of Higher Education he has been directed by the order of the Governor to convey the Higher Education Department's 'in principle approval' for establishment of a Government-aided General Degree College in the name of 'Siddhinath Mahavidyalaya' at Shyamsundarpur Patna in the district of Purba Medinpur subject to approval of the Finance Department and the Vidyasagar University. The Executive Council of Vidyasagar University also noted the letter bearing No. 504-Edn(U)/1U(VID)-11/13 dated 14.05.2013 received from the Higher Education Department, Government of West Bengal, University Branch in connection with granting affiliation to Siddhinath Mahavidyalaya. The Executive Council further considered the Inspection Report submitted by the duly constituted inspection team in connection with extending affiliation to the following Honours & General subjects in B.A. course of Siddhinath Mahavidyalaya (New General Degree College) from the academic session 2013-2014.

Resolved that the inspection report submitted by the duly constituted inspection team in connection with extending affiliation to Siddhinath Mahavidyalaya (New General Degree College) for conducting honours and general subjects from the academic session 2013-2014 be accepted and approved subject to the fulfillment of the following terms and conditions. Resolved also that the above mentioned course be conducted presently at "Harekrishnapur Sri Ramkrishna Vivekananda Milan Mandir. Resolved further that an undertaking be made by the Institution for recruitment of adequate teachers for honours teaching.

The terms & conditions of affiliation of the above courses:

- 01. The Governing Body of the College to be formed according to Vidyasagar University First Statutes, 1983 within one year from the date of affiliation.
- 02. The college must have a fixed deposit of Rs.15,00,000/= (Rupees Fifteen lakhs only).
- 03. One full-time and guest teachers duly qualified in each of the general subjects affiliated to be appointed by the college until the sanctioned permanent teachers are appointed. For honours subject adequate number of teachers both contractual and guest teachers will be appointed.
- 04. The selection of teachers for appointment on contractual and part-time basis to be made by a Committee constituted for this purpose and a subject expert nominated by the University in each subject to be included in the Selection Committee.
- 05. Allotment of classes and payment of salaries to part-time teachers to be made as per G.O. (Govt. of West Bengal).
- 06. The college must set up a Library immediately.
- 07. The college must purchase books of the affiliated subjects for at least Rs.1,80,000/= (Rupees one lakh eighty thousand only) at present for the college library.
- 08. The maximum number of students to be admitted into the 1st year classes in the following subjects are fixed as follows:

 (i) Sanskrit (H) 40, (ii) Bengali (G) 40, (iii) English (G) 40, (iv) History (G) 40, (v) Philosophy (G) 40, (vi) Sanskrit (G) 40 and (vii) Education (G) 40.
- 09. Two sections to be made for each of the compulsory Bengali, English and Environmental Science classes.
- 10. The college will be a normal day college.
- 11. The college must develop and maintain a play ground.
- 12. Separate Common Room will have to be provided for the Girls' students.
- 13. The approach road is to be developed.
- 14. The college will have to make provision for supply of water immediately.
- 15. The College will have to construct its own building within 2 (two) years from the date of affiliation.
- 16. The college shall give a declaration to the effect that it will bear all expenditure involved on the purchase of books, furniture and salaries of teaching and non-teaching staff of the college for such period until funds from the Government is released.
- 17. The college must abide by the Vidyasagar University Act, Statutes, Ordinance, Regulations etc.
- 18. The land available at this moment is highly inadequate to establish a college. Steps should be taken to acquire more land adjacent to the existing one to accommodate further extension and a play ground.

- 2. EIILM will take necessary steps to accord the approval from the All India Council for Technical Education (AICTE) for running the said course.
- 3. It should not be quoted anywhere that EIILM is an "Extended Campus of Vidyasagar University" or the M.B.A. course affiliated to Vidyasagar University is approved by All India Council for Technical Education (AICTE).
- 4. EIILM will take adequate measures to prevent the occurrence of any fraudulent practice in their institute.
- 5. EIILM will be guided by the terms, conditions and other aspects laid down in the MOU signed between Vidyasagar University and EIILM to run the said course.
- 6. If EIILM does not run the course properly the University authority will take necessary steps for de-affiliation as per MOU.
- 7. Sign-age may be used only in the context of "affiliation of 2-year regular M.B.A. course to EIILM by Vidyasagar University.
