### Resolution

The Executive Council of Vidyasagar University noted the letter dated 08.11.2012 submitted by Sri Surajit Sen, Technical Assistant who is under suspension stating that he is under suspension for about three years. Now he is facing much problem, physically, mentally and economically and also repentant. The Executive Council also noted that he has submitted several letters to the University authority requesting for joining the said post at Vidyasagar University. Now he has requested again to consider his appeal sympathetically and to give an opportunity to join the post in this University.

After thorough discussion on the matter and careful consideration of the letter of Sri Surajit Sen in connection with praying for giving the opportunity to join the post of Technical Assistant at Vidyasagar University it was resolved that a Committee consisting of (a) Dr. Bani Ranjan De, Department of Bengali and (b) Dr. Ashim Kumar Bera, Principal, Mahishadal Raj College be constituted to look into the matter along with necessary supporting documents and to submit a detailed report in this connection for further consideration.

# Agenda No. - 04

To place before the Executive Council the note dated 22.11.2012 prepared and submitted by the Finance Officer in connection with some suggestions regarding University medals, Endowment medals, scholarship and prizes for the Convocation of Vidyasagar University.

# Resolution

The Executive Council of Vidyasagar University noted the letter dated 22.11.2012 prepared and submitted by the Finance Officer stating that the University medals and endowment medals for the years 2009 & 2010 and 2010 & 2011 have been handed over to the recipients in the Sixteenth Convocation of Vidyasagar University held on 20.11.2012. As the price of gold and silver are increasing day by day the budget of the Convocation is increasing proportionately. In the last convocation (sixteenth) the total estimated cost of medals was Rs.13.00 lacs. The Executive Council also noted the suggestions submitted by the Finance Officer regarding medals, endowment medals, scholarships and prizes for the convocation of Vidyasagar University.

After careful consideration of the note dated 22.11.2012 prepared and submitted by the Finance Officer and thorough discussion on the matter regarding suggestions relating to University medals, Endowment medals, Scholarship & prizes for the Convocation of Vidyasagar University it was resolved that -

- (1) For creation of any Endowment Medal in this University a minimum amount of Rs.50,000/(Rupees fifty thousand) only be donated to the University henceforth.
- (2) For cash prize a minimum amount be deposited to the University whose interest amount comes to Rs. 300/- (Rupees three hundred) only per year henceforth.
- (3) A fee regarding Prize/Certificate/Convocation be charged @Rs.100/- per final year/ final semester student of DDE and Rs.40/- per final year/final semester regular postgraduate & undergraduate students of Vidyasagar University.
- (4) Those who have already created the Endowment Medal/cash prizes at this University with less amount as stipulated above decided by EC the concerned persons/incumbents be communicated to deposit the balance amount in this connection for continuation of the said medal/prize in this University.
- (5) After next Convocation of Vidyasagar University the decisions as stated above be reviewed.

Resolved further that the Registrar be requested to take necessary steps in this connection.

### Agenda No. - 05

To place before the Executive Council the note dated 03.12.2012 prepared and submitted by the Head of the Department of Physics and Techno-Physics in connection with Academic and Scientific Co-operation and Exchange Agreement between Vidyasagar University and Benemerita Universiad Autonoma de Peubla (BUPA).

# Resolution

In the current academic context it is found that a good section of students are pursuing professional Bachelor's degree i.e. BBA in distance mode as their graduation. A major section of these students are not able to undergo regular mode of education due to various reasons. Now they appeal to the University to introduce BBA in distance mode which will be immensely beneficial for student community of West Bengal.

After thorough discussion on the matter relating to introduction of B.B.A. course in distance mode of Vidyasagar University it was resolved that a two-member Committee consisting of (1) Prof. Kartick Chandra Paul and (2) Prof. R.P. Banerjee, EIILM, Kolkata be constituted to look into the matter regarding introduction of B.B.A. course under distance mode of Vidyasagar University and to submit a report in this connection for further consideration of EC. The Registrar will act as the Convener of the Committee.

If required, the amount can be deducted from his monthly salary in four to five installments, as acceptable by Mr. Barik.
- 2. Further, Mr. Barik may kindly instructed to maintain transparency for all financial transactions here after in the University system.
- 3. He may also kindly be warned that if such incidents are repeated by Mr. Barik in near future, the University authority may initiate disciplinary actions against him, without further information.

To consider the letter dated 22.01.2013 submitted by all employees of the Directorate of Distance Education (DDE) of Vidyasagar University in connection with appeal for making 'five working days week' instead of 'six working days week' at DDE.

#### Resolution

The Executive Council of Vidyasagar University noted the letter dated 22.01.2013 submitted by all employees of the Directorate of Distance Education of Vidyasagar University stating that they are performing their duties for six days in a week since 2004 while employees working in the other sectors of the University are performing their duties for five days in a week. Now, they are requesting the University authority to consider the matter and to take necessary steps to make 'five working days week' instead of 'six working days week'. They assure the University authority that they will gladly perform their duties (i.e. in Saturdays, Sundays and other holidays) without any extra payment but only against CCL(s).

After thorough discussion on the matter and careful consideration of the letter submitted by all employees of the Directorate of Distance Education of Vidyasagar University in connection with appeal for making 'five working days week' instead of 'six working days week' at DDE it vas resolved that new Regulations for the DDE be framed. It was also resolved that a Committee consisting of (1) Prof. Radharaman Chakrabarti, former Vice-Chancellor of Netaji Subhas Open University and (2) Prof. Subha Sankar Sarkar, Hon'ble Vice-Chancellor, Netaji Subhas Open University and (3) Registrar (Convener) be constituted to frame a new Regulations for DDE for further consideration of EC.
