### Agenda No. - 01

To consider the draft Annual Report of Vidyasagar University for the year 2011-2012.

#### Resolution

### Resolution

### Resolution

### Agenda No. - 04

To consider the letter dated 12.09.2012 submitted by the Core Teachers of the Directorate of Distance Education of Vidyasagar University in connection with change of the designation to Core-Faculty from Core-Teacher.

### Resolution

The Executive Council of Vidyasagar University noted the letter dated 12.09.2012 submitted by the Core Teachers of the Directorate of Distance Education stating that they have been serving as Core Teacher in respective subjects in DDE for a long period. The Executive Council also noted that as per the guidelines of Distance Education Council the designation "Core-Faculty" seems to be more appropriate than "Core-Teacher". In connection with the above they have requested to consider their application and to change their designation as Core-Faculty from Core-Teacher.

After thorough discussion on the letter of the Core-Teachers of the Directorate of Distance Education of Vidyasagar University in connection with change of the designation to Core-Faculty from Core-Teacher it was resolved that the designation of Core-Teachers engaged at DDE of Vidyasagar University purely on contract basis be changed as Core-Faculty. Resolved also that the nature of work of the Core-Faculty will remain purely on contract basis as was in case of Core-Teacher.

### Agenda No. - 05

To consider the letter dated 17.09.2012 submitted by Smt. Barna Chakraborty, Core-Teacher in Zoology, DDE in connection with renewal of her contract service for a further period as per the norms of the University.

#### Resolution

Barna Chakraborty, Core-Teacher in Zoology (on contract basis), Directorate of Distance Education, Vidyasagar University regarding renewal of her contract period as Core-Teacher in the said department of DDE.

Barna Chakraborty as Core-Teacher in Zoology, DDE of this University be renewed for a further period of one year with effect from the forenoon of 02.01.2013. Resolved also that the pay of the incumbent be fixed as per University rule.

### Resolution

The Executive Council of Vidyasagar University noted the letter No. 1099(10)-Edn(U)/1U-129/12 dated 10.12.2012 received from the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch stating that in the monthly review meeting held in Higher Education Department on 22.11.2012 a decision has been taken to request the State-aided Universities to take initiative for setting up teaching Department for performing Arts to promote talent in the State. Introduction of a course for performing Arts will enable the students to gain access to a course which has crucial importance in enriching the national culture of the country. In this connection she has requested to send a project report to the Higher Education Department emphasizing requirements for teaching faculty, infrastructure facilities and any other matter for introduction of the course in Vidyasagar University.

After thorough discussion and careful consideration of the letter of the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch in connection with Advisory for setting up teaching Department for Performing Arts in Vidyasagar University it was resolved that necessary steps be taken for introduction of Music and Performing Arts at Vidyasagar University. Resolved also that a Committee consisting of (a) Dr. Susanta Samanta, (b) the Secretary, Faculty Councils for P.G. Studies, (c) Dr. Bani Ranjan De, (d) one subject Expert of Music, (e) one subject Expert of Performing Arts and (f) the Registrar (Convener) be constituted to look into the matter and to prepare the comprehensive proposals for introduction of the said courses at Vidyasagar University and the said proposals be forwarded to Government of West Bengal for approval. Resolved further that the Hon'ble Vice-Chancellor be authorized to nominate the subject experts of the said Committee.

# Agenda No. - 08

To place before the Executive Council the letter No. 12-Edn(U)/1U-44/12 dated 02.01.2013 received from the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch in connection with proposal for opening of PG Courses in the affiliated colleges of Vidyasagar University.

# Resolution

The Executive Council of Vidyasagar University noted the letter No. 12-Edn(U)/1U-44/12 dated 02.01.2013 sent by the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch stating that the Department of Higher Education received a proposal from the Hon'ble M.P. of Loksabha for establishment of a State University in the district of Purba Medinipur. The said proposal was sent to West Bengal State Council of Higher Education and the Council accepts the proposal in principle. The Executive Council also noted that the Higher Education Department has thought it prudent to upgrade 4 existing undergraduate colleges in the district of Purba Medinipur to the level of PG Colleges as an interim measure since setting up of a University is a long drawn process. The Executive Council further noted that the DPI has identified four colleges namely, (1) Tamralipta Mahavidyalaya, (2) Panskura Banamali College, (3) Provat Kumar College and (4) Vivekananda Mission Mahavidyalaya for upgradation to PG colleges. Since the matter is very serious the Joint Secretary has requested the University to cause an inspection of the aforesaid colleges immediately to assess the suitability of those colleges for upgradation and

requirement of infrastructural facilities and additional teaching faculty to the colleges for running PG courses.

After threadbare discussion and careful consideration of the letter of the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch in connection with opening of PG courses in the affiliated colleges of Vidyasagar University in the district of Purba Medinipur it was resolved that two separate Inspection Teams as specified below be constituted to inspect the four affiliated colleges, namely, (a) Tamralipta Mahavidyalaya, (b) Panskura Banamali College, (c) Prabhat Kumar College, Contai and (d) Vivekananda Mission Mahavidyalaya as identified by the D.P.I. to see the feasibility and all other aspects for introduction of the P.G. courses from the academic session 2013-2014. Resolved also that the Hon'ble Vice-Chancellor be authorized to nominate the members of the Inspection Team. Resolved further that the Teams be requested to submit the reports in details in this connection for further action of the University authority.
