In this connection she has requested to grant her leave for attending the course work and the examination.*

But it is seen from the note submitted by the Establishment Section that Sk. Saju did not submit the medical papers properly and also fitness certificate in this connection. So he may not be granted medical leave for his treatment. He may be granted Earned Leave on medical ground subject to the approval of EC.*

#### Resolution

*The Executive Council of Vidyasagar University noted the letter F.No. DEC/03/DG/001/08/37/13521 dated 24.07.2012 received from the Joint Registrar, IGNOU stating that the Vidyasagar University has refunded the inadmissible amount of Rs.5,52,186/- under the head Development of course material and quality assurance and staff training. The above amount has been refunded to DEC without interest as the University kept the money for three years which was due on 31.07.2009. The Finance Department has raised an objection that the interest amount must be transferred in DEC account as per the terms and conditions of sanction order. In this connection he has requested to remit the interest amount so that the University may be eligible for the development grant in the current financial year.*

*After thorough discussion on the letter it was resolved that as desired by the Distance Education Council the interest amount accrued on the balance amount of development grant for the year 2008-2009 be remitted to Distance Education Council. Resolved also that the Registrar be requested to take necessary steps in this connection.*

#### Resolution

The Executive Council also noted that at present the amendment in the Statute as per the West Bengal University Laws (Amendment) Act - 2011 is under process and it has not been finalised.*

*After thorough discussion on the matter it was resolved that a clarification from the State Government be sought for whether the leave rules for the whole-time teachers of the Government-Aided Colleges (including erstwhile sponsored colleges) in the state as per G.O. No. 762-Edn(CS) dated 03.12.2009 passed by the Executive Council of Vidyasagar University be implemented before finalization of the Statute as per the West Bengal University Laws (Amendment) Act-2011 which is under process. Resolved also that the Registrar be requested to take necessary steps in this connection.*

#### Resolution

registration expired subsequently. He now wish to complete his Ph.D. work under Prof. K.C. Tudu, Head, Department of Santali, Ranchi University and intend to register himself afresh. In this connection he has requested to grant him necessary permission for prosecuting the said Ph.D. work. After careful consideration of the letter of Shri Shyam Charan Hembram regarding permission for pursuing Ph.D. work it was resolved that Shri Hembram be permitted to pursue the Ph.D. work without hampering the normal duty at Vidyasagar University.

### Resolution

*The Executive Council considered the Inspection Reports submitted by the duly constituted Inspection Team in connection with extending affiliation to (a) Pratap Chandra College of Education, Gopiballavpur and (b) Vidyasagar Teachers' Training Institute, Akalpoush in the district of Paschim Medinipur for conducting the B.Ed. Course from the academic session 2012-2013.*

*Resolved that (a) Pratap Chandra College of Education, Gopiballavpur and (b) Vidyasagar Teachers' Training Institute, Akalpoush be extended affiliation to conduct the B.Ed. course from the academic session 2012-2013 subject to the fulfillment of the following terms & conditions :*

*(a) Pratap Chandra College of Education :*

01. *The intake capacity at the initial stage for the above mentioned course is 100.*
02. *Students will be admitted purely on merit basis and the admission be made by the University centrally through counselling.*
03. *The College must have to maintain 200 (two hundred) working days in each academic session.*
04. *At least 1 (one) whole-time qualified teacher in each subject of Physical Education, English and Life Science are to be appointed immediately on receipt of the affiliation letter. Joining letters to be submitted to the University within 15 days alongwith a declaration that they are not engaged in any other institution.*
05. *Part-time teachers as and when required may also be appointed.*
06. *The full-time Principal of the College must be appointed as per norms of NCTE.*
07. *The college must abide by the Vidyasagar University Act, Statutes, Ordinances, Regulations etc. as amended from time to time.*
08. *The college must abide by the norms of the N.C.T.E. in this connection.*
09. *The college must build up a Reserved Fund of Rs.20,00,000/- (Rupees twenty lakhs) only within one year.*

10. Books worth Rs.1,00,000/- (both for english and Bengali version) in adequate number for different subjects as per syllabus are to be procured by the college.
11. Laboratory instruments worth Rs.50,000/- for Physical Science, Rs.40,000/- for Life Science and Rs.30,000/- for Geography respectively should be procured.
12. Subscription of Journal ( at least Five Journals) are necessary.
13. The following method subjects have been granted to Pratap Chandra College of Education for the session 2012-2013 :
  - (a) Bengali, (b) English, (c) History, (d) Mathematics, (e) Physical Science, (f) Life Science, (g) Geography and (h) Sanskrit.
14. Play Ground and facilities for outdoor and indoor games to be developed at the earliest.
15. Facilities for cultural activities to be created and maintained by the college.
16. Rs.1,500/- (Rupees one thousand five hundred only) per student per annum to be deposited by the college to the affiliating University.
17. More Laboratory equipments are to be purchased. Adequate number of Computers and other Lab. equipments are to be purchased.
18. Separate class rooms for method subjects are to be provided.
19. Common Room will have to be provided for the students.
20. Hostel facilities both for boys' & girls' should be provided.

14. Play Ground and facilities for outdoor and indoor games to be developed at the earliest.
15. Facilities for cultural activities to be created and maintained by the college.
16. Rs.1,500/- (Rupees one thousand five hundred only) per student per annum to be deposited by the college to the affiliating University.
17. More Laboratory equipments are to be purchased. Adequate number of Computers and other Lab. equipments are to be purchased.
