To place before the Court of Vidyasagar University, the letter bearing No. 914-HED-12016(45)/5/2021-UNV SEC-Dept. of HE dated 21.11.2022 received from the Special Commissioner, Department of Higher Education, Government of West Bengal, University Branch regarding Court's nominee for constitution of the Search Committee for selection of Vice-Chancellor of Vidyasagar University.

Resolution

The Court of Vidyasagar University noted that the Ninth Court of Vidyasagar University in its second (2nd) meeting held on 08.12.2021 based on the letter bearing No. 922-Edn(U)/VID(U)-5/99(PT-II) dated 29.10.2021 received from the Special Secretary to the Government of West Bengal, Higher Education Department, University Branch regarding nomination of Court's nominee for constitution of Search Committee for selection of Vice-Chancellor of Vidyasagar University unanimously resolved to nominate Professor Sabyasachi Basu Ray Choudhury, Hon'ble Vice-Chancellor of Rabindra Bharati University to the Search Committee and accordingly the same was communicated to the competent authority of the concerned department in this regard.

The Court of Vidyasagar University noted further the letter bearing No. 914-HED-12016(45)/5/2021-UNV SEC-Dept. of HE dated 21.11.2022 received from the Special Commissioner to the Government of West Bengal, Department of Higher Education, University Branch now requesting to send the name of the Nominee of the Court of Vidyasagar University as a fresh in terms of Section 9(1)(c)(iii) of the Vidyasagar University Act, 1981 as amended by the West Bengal University Laws Amendment Act, 2014 to constitute the Search Committee at the earliest for selection of Vice-Chancellor of Vidyasagar University as Professor Basu Ray Chaudhury has already been nominated as the nominee of the Hon'ble Chancellor in the Search Committee for this purpose.

The matter of nominating one person to the Search Committee as Nominee of the Court of Vidyasagar University was raised before the members of the House.

The name of Professor (Dr.) Manas Kumar Sanyal, Hon'ble Vice-Chancellor of the University of Kalyani, Nadia was proposed by Professor Tapan Kumar De, Dean (Actg.), Faculty Councils for Postgraduate Studies in Arts & Commerce of Vidyasagar University & Member of the Court and the same was seconded by Professor Indranil Acharya, Head, Department of English, Dr. Tarak Nath Sahu, Head, Department of Business Administration, Dr. Suratha Kumar Malik, Teacher-in-Charge, Department of Political Science and many other members of the Court in the house, as the member of the Search Committee.

After thorough discussion on the letter received from the Special Commissioner to the Government of West Bengal, Department of Higher Education, University Branch pertaining to nomination of Court's Nominee of Vidyasagar University as a fresh for constitution of the Search Committee for the appointment of Vice-Chancellor of Vidyasagar University, it was unanimously resolved that the name of Professor (Dr.) Manas Kumar Sanyal, Hon'ble Vice-Chancellor of the University of Kalyani proposed by Professor Tapan Kumar De be approved as the nominee of the Court of Vidyasagar University in the Search Committee to be constituted by the Higher Education Department, Government of West Bengal for this purpose and the same be forwarded to the Department of Higher Education, Government of West Bengal for necessary action in this regard by the Registrar of this University.

During the discussion on this item, Professor Sibaji Pratim Basu, present Vice-Chancellor of Vidyasagar University abstained in the meeting and Professor Satyajit Saha, Dean (Actg.), Faculty Councils for Postgraduate Studies in Science presided over the said discussion.

Resolved also that the decision as stated herein above taken by the Court in its aforesaid meeting be also confirmed and the Registrar of this University be requested to process further in this regard.
