The Executive Council of V idyasagar University noted the letter No. BVB/5425 dated 29.02.2012 submitted by the Joint Director, Bharatiya Vidya Bhavan, Institute of Indian Culture, Kolkata stating that they are interested in starting the M.B.A. Degree Course under Distance Learning Mode with the affiliation of our esteemed University in their Bhowanipur Campus, namely, Asutosh College of Communication & Management, Kolkata. BVB has grown into a worldwide reputed institution promoting intellectual, cultural and educational movements with 119 centres of which seven are outside India and with 367 Constituent Institutions spread all over India and the World. BVB currently runs a reputed Higher Secondary School, M.B.A. Degree College and a College conducting postgraduate professional courses. Bhawan's college in Bhowanipur, Kolkata can boast of having a well equipped library consisting of more than one thousand books, a computer lab, a seminar room which can accommodate more than one hundred and fifty people, well furnished class rooms, and other facilities required to conduct the M.B.A. Course. The Executive Council further noted the resolutions of the General meeting of the Association in this connection submitted by them.

The Executive Council of Vidyasagar University appreciated the proposal relating to admission to B.Ed. Course and Course fee for the session 2012-2013 submitted by the Association of Self Financing B.Ed. Colleges. After careful consideration of the proposal submitted by them it was resolved that the proposal be not accepted at the moment as the matter relating to fee-structure of the B.Ed. Course is subjudice.

To re-consider the decision of the Executive Council taken in its meeting dated 05.04.2012 in connection with granting Study Leave to Dr. Biswajit Sarkar, Assistant Professor, Department of Applied Mathematics with Oceanology and Computer Programming for postdoctoral Fellowship at Pusan National University, Pusan, South Korea.

Resolution

The Executive Council of Vidyasagar University noted that the matter relating to granting of Study Leave to Dr. Biswajit Sarkar, Assistant Professor, Department of Applied Mathematics with Oceanology and Computer Programming was placed before the Executive Council in its meeting dated 05.04.2012 wherein it was decided that the Study Leave be granted to Dr. Biswajit Sarkar, Assistant Professor, Department of Applied Mathematics withOceanology and Computer Programming as per University rule for his postdoctoral fellowship at Pusan National University, Pusan, South Korea. The Executive Council also noted that as per the Uniform Leave Rules for the whole-time employees of the Universities it is stated that Study leave for advanced study and research directly related to his/her work in the University may be granted to a teacher by the Executive Council/Syndicate provided the concerned teacher has put in at least three years service and is not due to retire there from within five years of his /her return from such leave. There shall be a gap of at least three years between two periods of such leave. The Executive Council noted further that as per the record it is found that he is not entitled to get such leave as per rule as he does not fulfill 3 years of continuous service in this University.

After thorough discussion on the leave rules and careful consideration of the prayer of Dr. Biswajit Sarkar it was resolved that leave with full-pay during the period from 11.05.2012 to 30.04.2013 be granted to Dr. Sarkar in order to pursue Post-doctoral research at Pusan National University, Pusan, South Korea subject to submission of an undertaking on a Non-Judicial Stamp Paper stating that he will come back to the University after completion of the fellowship and will serve at the University for a minimum period of three years.
