#### Resolution

The Court of Vidyasagar University noted the letter bearing No. 922-Edn(U)/VID(U)-5/99(PT-II) dated 29.10.2021 received from the Special Secretary to the Government of West Bengal, Department of Higher Education, University Branch pertaining to nomination of Court's Nominee of Vidyasagar University for constitution of Search Committee in terms of provision of Section 9(1)(c)(iii) of the Vidyasagar University Act, 1981, as amended by the West Bengal University Laws (Amendment) Act, 2014, for selection of Vice-Chancellor of Vidyasagar University.

The matter of nominating one person to the Search Committee as Nominee of the Court of Vidyasagar University was raised before the members of the House.

The name of Professor Sabyasachi Basu Ray Chaudhury, Hon'ble Vice-Chancellor of Rabindra Bharati University was proposed by Professor Tapan Kumar De, Dean (Actg.), Faculty Councils for Postgraduate Studies in Arts & Commerce of Vidyasagar University & Member of the Court and the same was seconded by the most of the members of the Court in the house, as the member of the Search Committee.

After thorough discussion on the letter received from the Special Secretary to the Government of West Bengal, Department of Higher Education, University Branch pertaining to nomination of Court's Nominee of Vidyasagar University for constitution of Search Committee for the appointment of next Vice-Chancellor of Vidyasagar University, it was unanimously resolved that the name of Professor Sabyasachi Basu Ray Chaudhury, Hon'ble Vice-Chancellor of Rabindra Bharati University proposed by Professor Tapan Kumar De be approved as nominee of the Court of Vidyasagar University in the Search Committee to be constituted by the Higher Education Department, Government of West Bengal for appointment of the next Vice-Chancellor of Vidyasagar University and the matter be forwarded to the Higher Education Department, Government of West Bengal for necessary action in this regard.

#### Resolution

The Court of Vidyasagar University noted the Notification baring No. 148-L/VID(U)-5/99 (part-II) dated 05.07.2021 issued by the Special Secretary to the Government of West Bengal, Higher Education Department stating that the competent authority of the State Government in exercise of the power conferred by section 59 of the Vidyasagar University Act, 1981 read with the provisions under clause (b) of sub—section (5) of section 9 of the Vidyasagar University Act,1981, as amended in 2011, decided to appoint Prof. (Dr.) Sibaji Pratim Basu, Professor of Political Science and the Dean of Faculty of Arts & Commerce of Vidyasagar University to exercise the powers and perform the duties of the Vice Chancellor for a period of six months, or until appointment of a regular Vice-Chancellor, or until further order, whichever is earlier with effect from 06.07.2021 (forenoon).
