#### Resolution

The Court of Vidyasagar University noted the Order bearing No. 08-EH/N/M&MS-06/2013 (Pt.-I) dated 28.07.2017 issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch stating that the Governor has been pleased to order that there will be a sub-scheme under Swami Vivekananda Merit Cum Means Scholarship Scheme which will be known as 'K-3 Component" and the Kanyashree girls, who are enrolled in Kanyashree Prakalpa of the Department of Women and Child Development and Social Welfare and have received financial assistance under Kanyashree Prakalpa, stage-2 (K-2), if admitted in Postgraduate courses, may apply for getting financial assistance under the 'K-3 Component' of Swami Vivekananda Merit Cum Means Scholarship Scheme. The Kanyashree girls, whether single or married, may apply for financial assistance for pursuing PG studies under the said scheme if they get at least 45% marks in graduation and enroll themselves for PG studies. For pursuing PG studies in Arts & Commerce, each K-3 beneficiary will receive rupees two thousand (Rs.2,000/-) only per month and for pursuing postgraduate studies in Science, each K-3 beneficiary will get rupees two thousand five hundred (Rs.2,500/-) per month.

After thorough discussion on the order issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch pertaining to providing the financial assistance to Kanyashree girls under Swami Vivekananda Merit Cum Means Scholarship Scheme in order to encourage & incentivize them for pursuing Post Graduate Studies, it was resolved that the said scheme taken by the Higher Education Department be accepted and approved. The Court also appreciated for introduction of such a scheme by the Higher Education Department. Resolved also that a thanks letter be sent to the Higher Education Department, Government of West Bengal in this regard.

The Governor is further pleased to say that the financial assistance will be admissible to those non-NET candidates and NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter, with effect from 01.04.2017.

After thorough discussion on the Orders issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch pertaining to providing financial assistance to the Non-NET & NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter with effect from 01.04.2017, it was resolved that the said fellowship taken by the Higher Education Department be accepted and approved. The Court also appreciated for introduction of such fellowship by the Higher Education Department.
