The Revised Rules and Regulations for the Admission and Examinations of FIVE YEARS B.A. LL.B. (Hons) Course and the TIREE YEARS LL.B. Course of the University.

I. THE DEGREE OF LL.B.

The Degree of Lt.B. may be conferred to such candidates who have:

- i.(a) Secured a minimum of 45% marks in aggregate at Graduation and such candidate's admission was confirmed through admission test for Three years LL.B. to be conducted by the Concerned College.
  - (b) Secured a minimum of 45% marks to aggregate at 10 + 2 pattern and such candidate's admission was confirmed through Admission Test of Five Years LL.B. (Hons) to be conducted by the concerned College. Age limit 20 years at the time of Selection (2 years relexation for reserved category)
- di. received regular instructions
- iii. attended not less than 75% of the classes held
- iv. undergone required practical training
- v. maintained good moral character and
- vi. have complied with such othercondition or conditions as may be laid down by the competent authority of the University from time to time.

#### CURRICULUM OF STUDIES

The curriculum of studies shall consist of Thirty papers of one hundred marks each for Three year LL.B. Course and Sixty Papers of one hundred marks each for Five years B.A. L.L.B (Hons) course.

### DURATION OF THE COURSE

The duration of the course shall be three academic years (Six Semesters) for three years LL.B. course and for Five years B.A. LL.B (Hons) Course the duration of the course shall be five academic years (Ten semesters) THE SYSTEM, METHODOLOGY AND MECHANISM OF EVALUATION

A. EVALUATION OF TAUGHT PAPERS

Coneral Scheme: All Taught papers shall carry 100 marks.

The performances of the students in each taught paper shall be assessed through External Assessment (done by the University) and internal Assessment (done by the Colleges as per University instruction). The External Assessment shall carry 80 marks and the Internal Assessment shall also carry 20 marks. Internal Assessment be done through atleast 3 College Test & Averagem 3 Class Test be send to University. Scripts will be preserved by the College Concerned for atleast xx 2 years.

External Assessment: The External Assessment which carries

80 marks shall be done through an End Semester Examination conducted by the University during the First week of the 6th month of each Semester. The detailed rules of the External Assessment shall be as under:

# Appointment of Paper Setters, Moderators, Examiners and

Tabulators: The Paper Setters, Moderators, Examiners and Tabulators shall be appointed by the competent authority of the University in accordance with the established norms followed by the University. Keeping in mind the Semester-pased system and professional nature of the Course as far as practicable, there shall be two Paper Setters for each paper.

Full marks, Pattern and Duration of the End Semaster Written

Examination: The End Semester Written Examinationnshall carry 80 marks and shall be of three (3) hours duration. general, the End Semester Written Examination should ideally be based on requiring the students to apply the legal principles (which they have learnt in course of their study) to various practical problems of ground reality so that the Examination does not turn out to be a mere test of memory. The Question Papers to be prepared for the End Semester as per University norms. Written Examination shall contain 07 Seven questions of fifteen (1 5) marks carring the syllabus and the examinees shall be asked to write four questions out of the said right seven (7) Questions. As far as practicable questions shall be gramed in such a manner so that each question consists of two parts wherein the first part shall be theory based and the last part shall be problem based. #### EVALUATION OF PRACTICAL PAPERS

All practical Fapers (i.e. Paper XXXIII Moot Court, Freparations and Participations in Trial Proceedings, Paper XXXIV Drafting, Pleading and conveyancing, Faper XXXV Professional Ethics, Accountancy for Lawyers and Bar Bench Relations and Faper XXXVI Public Interest Lawyering, Legal Aid and Paralegal Services) shall be assessed through Internal Assessment conjucted by the Colleges strictly in accordance with guidelines laid down by the Bar Council of India.

At the end of the VIth Semester (for Three year LL.B) and Xth Semester (for Five Years B.A. LL.B. (Hons)) the Colleges are required to send a statement showing the marks secured by the students in the Fractical Paper.

## PUBLICATION OF THE RESULT FROMOTION AND LASS MARKS

The End Semester Written Examination to be conducted by the University shall be held during the First Week of the 6th month (i.e. First Week of June for the Semister that commences on and from the month of January and the First Week of December for the Semester that commences on and from the month of July) of each Semester.

All written papers of the End-Semsster-Written-Examination shall be evaluated and examined as early as possible. The papers of the End-Term-Written-Examination shall be examined and assessed through suitable system as it be fit for the Authority.



- The results of a Semester shall be published and be made availble to the students within two months from the date of completion of the End-Semester-Written-Examination.
- iv. A student who has attended 75% of the classes held and appeared in all the papers of the End-Semester-Written Examination shall authmatically be promoted to subsequent semester for attending the classes concerned.
- A student is required to secure an aggregate 40% marks (i.e. 240 marks in aggregate) besides securing a minimum pass marks of 30% in each paper (whether the same is a Taught Paper of Seminar Paper or Fractical Paper) for passing a semester. in 5 years LL.B (H) Course. And in case of 3 years LL.B. Course a student is required to secure an aggregate, besides securing a minimum Raper Pass marks of 30% in each paper (Taught Paper/Seminar Paper/Practical Paper) for Passing a Semister.
- A student failing in a Semester Examination is not eligible vi. to xxx sit for the next End Semester Examination.
  - ii. A student who has got below 30% amerks in one or more (Maximum three) Paper/Papers shall be required to appear in the Written Examination of the Paper/Papers in which he/she has got below 30% marks along with the students of the following batch and if a student fails to secure 30% Marks in the Paper/Papers taken by him/her again, after the third attempt he/she shall be required to register

himself/herself for that Semester and shall be required to take all Papers offered in the particular semester again. viii. A student who has got 60% and above marks in aggregate be

awarded 1st class and a student securing 50% and above but below 60% marks in aggregate be awarded 2nd glass.
