Oral Mention

- 01. Dr. Asim Kumar Bera pointed out that necessary steps are to be taken for opening the Academic Staff College of UGC at Vidyasagar University. Prof. Susanta Kumar Chakraborty and Prof. Bikash Ranjan Pati supported the said issue. Registrar pointed out that the University had applied the UGC for opening the Academic Staff College during XIth Plan period but it was regretted.
- 02. Prof. Arunodoy Saha pointed out that OMR Sheet may be introduced for Internal Assessment. Shri U.S. Mondal supported the said issue. Dr. Kishore Kumar Rarhi pointed out that use of O.M.R. Sheet will not be so off active for evaluation of both subjective and objective evaluation.
- 03. Dr. Durga Sankar Rath wanted to know the status of Librarian of the Colleges.
- 04. Prof. Arunodoy Saha pointed out that to commemorate the 150th Birth Anniversary of Swami Vivekananda an Inter Disciplinary Centre may be introduced in Vidyasagar University. Prof. Saha pointed out further that a Chair Professor in the name of Vivekananda may be created in this University. Dr. Subrata Ghosh mentioned that the West Bengal State Council of Higher Education may be approached in this connection.
- 05. Prof. Susanta Kumar Chakraborty pointed out that to commemorate the 150th Birth Anniversary of Professor Acharya Prafulla Chandra Roy an Inter Disciplinary Centre may be introduced in this University. Shri U.S. Mondal mentioned that the Centre may be introduced jointly in the name of Professor Acharya Prafulla Chandra Roy and Professor Acharya Jagadish Chandra Bose. Prof. Susanta Kumar Chakraborty pointed out also that the West Bengal Government may be approached in this connection.
- 06. The Hon'ble Vice-Chancellor pointed out that the University authority has already submitted the proposals to the UGC XIIth Plan period for introduction of two Inter Disciplinary Centres at Vidyasagar University.

Resolution

The Court of Vidyasagar University noted the amendment in the Statute proposed by the Committee constituted by the Court in its first meeting dated 04.04.2012. The Court also noted the progress of the amendment in the Statute of Vidyasagar University raised by the Registrar in details. The Court further noted that the Seventh Executive Council of Vidyasagar University in its meeting dated 04.05.2012 re-constituted the Act and Statute Amendment Committee consisting of (1) The Vice-Chancellor – Chairman, (2) The Finance Officer, (3) Prof. Falguni Chakraborty, (4) Prof. Ambarish Mukhopadhyay, (5) Prof. Rajat Acharyya, (6) Dr. Koushik Sankar Bose, (7) Dr. Kanailal Paria, (8) One Legal Expert, (9) Dr. Uday Chand Pal, (10) Dr. Manabendra Mondal and (10) Registrar - Secretary.

Resolved that the Act and Statute Amendment Committee re-constituted by the Executive Council of Vidyasagar University be ratified.

Agenda - 03

To discuss the matter relating to next Convocation (Sixteenth) - 2012 of Vidyasagar University.

Resolution

The Court noted that due to general election of West Bengal Assembly - 2011 and after the election there was an embargo from the Government excepting taking minor decisions the Convocation in the year 2011 could not be held. The Hon'ble Vice-Chancellor proposed that there should be a fixed date for holding the Convocation of Vidyasagar University in every year.

After thorough discussion on the matter relating to holding the Convocation of Vidyasagar University the Court unanimously resolved that the Convocation of Vidyasagar University be held on 26th September every year to commemorate the birth day of Pandit Iswar Chandra Vidyasagar after whose name the University is established. The Court also resolved that the Sixteenth Convocation – 2012 of Vidyasagar University be fixed on 26th September, 2012 tentatively subject to the approval of the Hon'ble Chancellor.

The Court further discussed the matter relating to the honorary degrees (honoris causa) to be conferred upon the persons of eminence in the Sixteenth Convocation - 2012 of the University and three persons of eminence may be conferred the honorary degrees (honoris causa) in the said Convocation. The Court again discussed the matter regarding invitation of the Guest-in-Chief in the said Convocation who may also deliver the Convocation address. The following members of the Court proposed the names of the following persons of eminence for conferment of honorary degrees (honoris causa) and Guest-in-Chief in the Sixteenth Convocation of Vidyasagar University.

Resolved also that the panel of 5 persons of eminence prepared by the Hon'ble Vice-Chancellor and also suggest the name of the Guest-in-Chief of the Convocation be sent to the Hon'ble Chancellor for his confirmation of 3 persons of eminence out of the panel of the Vice-Chancellor for conferment of the honorary degrees and also the Guest-in-Chief of the Sixteenth Convocation of Vidyasagar University.

To nominate one person to form Search Committee in connection with the appointment of the next Vice-Chancellor of the University as per provisions of clause (c) and item no. (iii) of sub-section (1) of Section 9 of the West Bengal University Laws (Amendment) Act, 2011 (West Bengal Act No. XII of 2011).

Resolution

The Court noted the letters bearing Nos. 206-Edn(U)/Vid(U)-5/99 dated 05.03.2012 and 480-Edn(U)/VID(U)-5/99 dated 15.05.2012 received from the Secretary to the Chancellor, Chancellor's Secretariat, Department of Higher Education, Government of West Bengal in connection with sending the name of the nominee of the Court in the Search Committee for appointment to the post of Vice-Chancellor of Vidyasagar University. The Court also noted that in pursuance of the provisions of clause (c) and item no. (iii) of sub-section (1) of Section 9 of the West Bengal University Laws (Amendment) Act, 2011 (West Bengal Act No. XII of 2011) the Court of the Vidyasagar University shall nominate one person to form the Search Committee. The Search Committee will recommend to the Chancellor a panel of three persons for appointment of the next Vice-Chancellor of the Vidyasagar University.

The matter of nominating one person to the Search Committee as Nominee of the Court of Vidyasagar University was raised before the members.

The name of Professor Y. Vaikuntham, Tagore National Fellow, at the Andhra Pradesh State Archives in Hyderabad and former Vice-Chancellor of Kakatiya University, Warangal, former Professor of History & former Dean of Faculty of Social Sciences, Osmania University, Hyderabad was put forward by Dr. Subrata Ghosh and the same was seconded by Shri U.S. Mondal and Prof. Arunoday Saha. However, Prof. Syed Sirajul Islam proposed the name of Prof. S. K. Brahmachari, Director General of Council of Scientific and Industrial Research as the member of the Search Committee.

After thorough discussion on the matter relating to nomination of one member in the Search Committee the Court unanimously resolved that the name of Professor Y. Vaikuntham proposed by Dr. Subrata Ghosh be approved as nominee in the Search Committee for appointment to the next Vice-Chancellor of Vidyasagar University.
