#### **Paper 6.5: Moot Court & Internship (Clinical Paper –IV) as prescribed by BCI**

This paper shall have three components of 30 marks each and Viva for 10 marks.

- a) Moot Court (30 Marks), every students may be required to do at least three moot courts in a year with 10 marks for each. The moot court work will be on assigned problem and it will be evaluated for 5 marks for written submission and 5 marks for oral advocacy.
- b) Observance of trial in two cases, one civil and one criminal (30 marks), students may be required to attend two trial in the courts of the last two or three years of LL.B. studies. They will maintain a record and enter the various steps observed during their attendance on different days in the court assignment. The scheme will carry 30 makes.
- c) Interviewing techniques and pre-trail preparations and internship diary (30 marks): each student will observed two interviewing session of client of the lawyer's Chamber? Legal aid office and record the proceedings in a dairy, which will carry 15 marks. Each students will further observe the preparation of documents and court papers by the advocate and the procedure for the filling of the suit/petition. This will be recorded in the dairy.  
Which will carry 15 marks.
- d) The fourth component of this paper will be Viva-Voce Examination on all the above three aspects. This will carry 10 marks.
